Re: Update to September 8, 2020 and April 23, 2021 Correspondence - Notice of Plant Closing and Layoffs

Dear Dislocated Worker Unit:

I am updating the prior correspondence dated September 8, 2020 and April 23, 2021.

Regal Beloit America, Inc. (“Regal” or the “Company”) expected to permanently close its entire Evans Avenue manufacturing facility located at 2300 Evans Ave., Valparaiso, IN 46383 (the “Facility”), effective on or about May 31, 2021 but now expects to permanently close its entire Facility effective on or about September 3, 2021. In connection with these plans, the Company expects that the employment of all 63 employees working at the Facility will cease and that the first 4 layoffs and/or employment separations took place on or about November 9, 2020, when the Company also expected the plant closing to commence, or during the 14-day period beginning on that date. The Company expected an additional 2 layoffs and/or employment separations took place on or about November 27, 2020, or during the 14-day period beginning on that date. The Company expected an additional 2 layoffs and/or employment separations took place January 4, 2021, or during the 14-day period beginning on that date. Whereas the Company expected 8 layoffs and/or employment separations will take place on or about May 31, 2021, or during the 14-day period beginning on that date, Company now expects 5 layoffs and/or employment terminations will take place on or about May 31, 2021, or during the 14-day period beginning on that date. The Company expects an additional 3 layoffs and/or employment separations will take place on or about June 22, 2021, or during the 14-day period beginning on that date. The Company expects an additional 15 layoffs and/or employment separations will take place on or about July 30, 2021, or during the 14-day period beginning on that date. The Company expects an additional 27 layoffs and/or employment separations will take place on or about September 3, 2021, or during the 14-day period beginning on that date.


There are no bumping rights available to affected non-Union employees. There are bumping rights available to affected Union employees according to Union Company agreements.
