**To Whom It May Concern:**

This letter constitutes formal written notice under the Federal Work Adjustment and Retraining Notifications Act ("WARN") that SMI Division of DCX-CHOL Enterprises, INC ("SMI") will be closing its Fort Wayne facility located at 1615 East Wallace Street, Fort Wayne, IN 46803. This plant closing is expected to be permanent. As a result of the closure, we anticipate that approximately 52 employees will be terminated, with separations commencing on January 31, 2021. No bumping rights are available. The bargaining union; RETAIL, WHOLESALE AND DEPARTMENT STORE UNION, U.F.C.W., AFL-CIO, Local 835 through their chief elected officer, Ms. Dianna Black, 5435 Salem Lane, Fort Wayne, IN, 46806 as well as the local rep has been notified.

SMI will notify all affected employees on December 1, 2020 that their employment with the Company will permanently terminate. These notices will be delivered by hand delivery or U.S. Mail.

We are committed to making this transition as smooth as possible for our employees, customers, and the community.
