Re: Notice of Tyson Foods, Corydon, IN Complex Closure

Dear President Rhoads and the Indiana Department of Workforce Development:

This notice is provided to you pursuant to the Worker Adjustment and Retraining Notification Act of 1988 (WARN Act). As part of the company's business strategy to operate more efficiently, Tyson Foods has determined that it must permanently close all locations that are part of the Corydon, Indiana complex (the "Complex") and permanently eliminate all jobs at those locations, including the Corydon plant located at located at 545 Valley Rd Corydon, IN 47112. Tyson Foods regrets that its team members must be displaced yet hopes to accomplish this plant closing with the least possible disruption to team members, their families, and the community.

The last day of production at the Corydon plant is anticipated to occur on or about March 1, 2024. As production is expected to cease at that time, the employment of approximately 368 affected team members will be permanently terminated, beginning on or about March 1, 2024, which is more than 60 days from the date of this notice. A listing of the affected Complex locations, the job titles of affected positions and the number of team members in each position is attached. See Attachments A-B.

The incumbents in the positions to be eliminated will be notified personally of their job elimination. Employees in some of the affected positions are represented by:

• Local 227, United Food & Commercial Workers Union (representing certain employees at the plant)

Because of the nature of our business, Tyson Foods is determining whether and what positions may be needed past the date above in connection with winding down operations and closing the Complex. If and when that determination is made, Tyson Foods will provide an updated notice and schedule to you and will personally notify any team members who are asked to extend their employment past the date above.

There are Collective Bargaining agreements in place for team members in the applicable Bargaining Units that govern "bumping rights" (the right of one team member to take another's job). However, since those locations are closing entirely, there is no bumping. There are no "bumping rights" for positions/team members that are not part of a Bargaining Unit.
