CALL TO ORDER

Lori Tubbs called the meeting to order.

Audra Peterson introduced Tammy Jones to the meeting.

Consent Agenda

Ms. Tubbs asked the Board Members to review the items on the consent agenda.

Motion: A motion was made by Jim Clarida and seconded by Audra Peterson to accept the consent agenda as presented. All were in favor. **The motion passed.**

1. Board Business

Dashboard/Performance

Ms. Neary presented the May 2025 Board report

Goal #1 Increase skills of current workforce to align with economic development strategies and key industry clusters Adult Education is continuing to expand their reach within the community, hosting new testing sites in both Knox and Winamac

Goal #2 Improve employer access to qualified workers and awareness of training resources:

Successfully launched weekly, pre-employment WorkKeys test for up to 20 candidates at WorkOne LaPorte for Howmet Aerospace as part of their talent recruitment strategy for 8 high impact roles.

Goal #3 Ensure Youth in NWI are positioned for continued education/learning and workforce

success: A total of 2,061 students from 24 Region 1 high schools are currently participating in the 2024-2025 Work Ethic Certificate Program, of whom 1,119 are members of the graduating class of 2025.

Goal #4- Increase quality job exposure and experience through apprenticeships, work-based learning, employer supported training programs: Collaborated with United Way to pool expertise of leveraging systems to maximize referral efficiency while providing more holistic support to clients.

Goal #5 Assure compliance and efficient operations of a workforce development system: CWI to lead a summer youth project with the City of Gary in partnership with Goodwill.

Adam Collins Resignation

Ms. Daugherty thanked Adam Collins who submitted his resignation for his dedication and service to the Board and asked the board to approve the resignations.

READY NWI Advocacy

Nicky Rodriguez Director of Ready NWI (Regional Education and Employer Alliance for Developing Youth) which is the consortium of educators, joined the meeting to discuss some of the challenges as it relates to the program. Ready NWI has 43 school districts in 7 counties. The original mission of Ready was aligned with the Lumina Foundation to accelerate year by year progress in achieving our vision by engaging students and their parents with a wide array of educational and occupational choices that lead directly to success in employment and with post high school degree and credential attainment. Ms. Rodriguez talked about the significant changes to the Commission for higher education and the Department of Educations' budgets as it relates to career coaching and Intermediary. Ms. Rodriguez is bringing this to the boards' attention in hopes to get attention and advocate withing their networks of the importance of Ready NWI.

3. Reports

Youth Employment Council

Ms. Stump gave the Board an update on work ethics. There were 2,061 participants for the regional work ethic certificate. 258 freshman, 218 sophomores, 486 juniors and 1,119 seniors. The Next Gen Expo was held at the Dean and Barara White Center in Merrillville In. on April 9th. There were over 200 youth that attended. There was also a NextGen expo at West Central High School as part of the Bridging the Gap Initiative, they had 10 vendors, and 200 students attend.

President's Report

Ms. Daugherty talked about the JAG Program (Jobs for American Graduates) funding for that program is in jeopardy of being cut, once the decision is made CWI will be forced to start dismantling. In addition to Jag funding being cut, the Readi Northwest Indiana which we used for incumbent worker training and work-based learning has also been cut. The Workforce Innovation Opportunity Act is the Federal legislation that provides parameters for the structure of the board and how the funding flows from Federal to the State down to the local regions, has been in reauthorization for a couple of years and we are expecting that to be a fraction of what it was.
