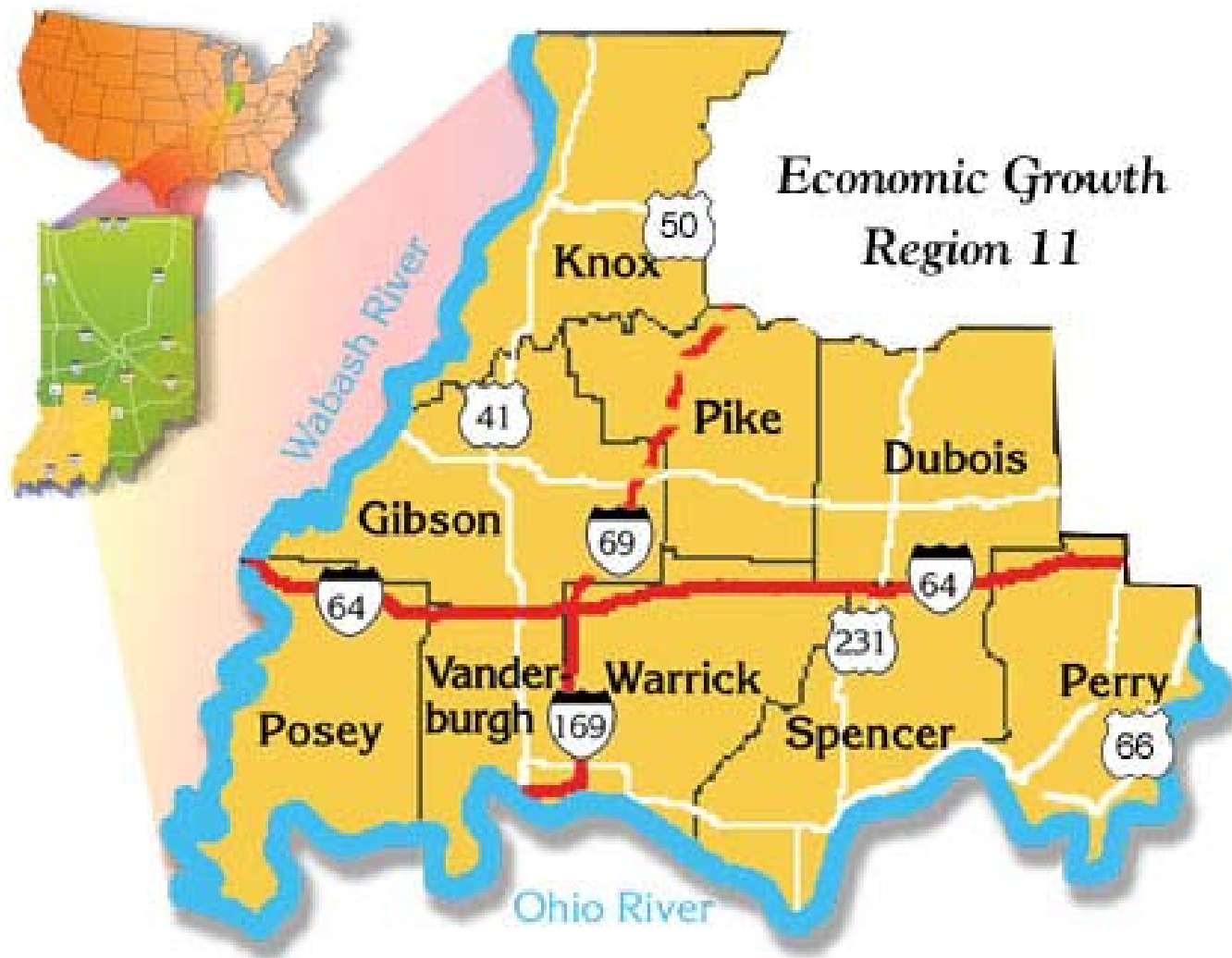

Should such contact occur, the Board reserves the right to reject the offending bidder.

Purpose

- Solicit competitive proposals to serve Adult, Dislocated Worker, Youth and One-Stop Operator under the Workforce Innovation & Opportunity Act (WIOA) in Region 11.
- The Board anticipates awarding one or more contracts.
- The Board reserves the right to award either performance based or cost reimbursement contracts at its discretion.
- Contract is anticipated to be for two (2) years with Board option for year three (3).
- May bid on One Stop Operator or Youth separate from Adult and Dislocated Worker.

Other

- The needs of business and employees in Region 11 are met.
- Appropriate services are provided.
- Appropriate assistance for eligible Youth with partnerships to help impact Youth.
- Jobs for America's Graduates (JAG) is model for Youth Program.
- Anticipated funding PY20: Youth \$400,000, Adult \$300,000 and Dislocated Worker \$300,000
- Funding may be adjusted up or down at discretion of the Board as allowable by PY20 allocations
- Board reserves the right to approve director of operations and executive director as well as the One-Stop Operator.
