The Child Care and Development Fund is a federal program that helps low-income families obtain child care so that they may work, attend training or education programs, or search for a job. The purpose of CCDF is to increase the availability, affordability and quality of child care. Providers authorized for CCDF may receive payments directly for eligible children attending their programs. CCDF programs can access following supports from the CCDF policy team:

- ▶ Vendor payment device
- ► Attendance questions
- Payment questions
- Complaint situations
