The Division of Mental Health and Addiction created a directory as a resource for the public as well as providers to learn about ASAM Designated Addiction Residential Treatment Facility resources potentially available to individuals, youth or adults, who are in need of substance use treatment.

Most ASAM Designated Addiction Residential Treatment facilities are still accepting patients during this COVID-19 pandemic time. The intake/admissions process for each open Residential Treatment unit who responded to DMHA's survey as of April, 24, 2020, are listed here. Abbreviations:

ASAM 3.1 - Clinically Managed Low-Intensity Residential Services - this adolescent and adult level of care typically provides a 24-hour living support and structure with available trained personnel, and offers at least 5 to 20 hours of clinical service a week.

ASAM 3.5M – Clinically Managed Medium-Intensity Residential Services - this level of care provides 24-hour care with trained counselors for children and adolescents, and offers more than 20 hours of clinical services seven days a week.

ASAM 3.5H – Clinically Managed High-Intensity Residential Services - this level of care provides 24-hour care with trained counselors for adults, and offers more than 20 hours of clinical services seven days a week.
