Investments Made To Date

FSSA is leveraging Build Learn Grow (BLG) funds, which includes CRRSA and ARPA grants, available through 2025 and 2026 to achieve our Agency-Wide BLG Outcome Targets through responsible investments. We recognize the need for immediate financial relief balanced with deliberate sustainability planning.¹

Most CRRSA grants ended September 30, 2023. Some exciting highlights below:



\$225M Invested in Early Childhood Programs

\$82M in Build, Learn, Grow Scholarship funds

\$70M in Child Care Voucher payments

\$73M across 12 other initiatives, including new hire stipends for providers, expansion of qualifying activities, and waived CCDF co-pays



\$29M invested in Mental Health Services

\$3M in local project funding for community organizations

\$4M across several initiatives to support and expand Indiana's peer support infrastructure

\$22M across over 20 other initiatives, including support for crisis response, workforce development, and substance use disorder treatment



\$7M invested in Services in the Home or Community

\$3M in Nutrition Grants for older Hoosiers

\$1M in grants to support older Hoosier vaccinations

\$3M across 8 other initiatives, including support for the Long-Term Care (LTC)
Ombudsman and Adult Protective Services (APS) programs



Services In The Home and Community

The Division of Aging (DA), Division of Disability & Rehabilitative Services (DDRS), Division of Family Resources (DFR), and Office of Medicaid Policy & Planning (OMPP) are responsibly leveraging BLG funds to enhance availability and quality of services used by individuals in the home and community in alignment with Indiana PathWays to Aging, which is set to launch in the summer of 2024.1

Investments Serve Individuals in the Home and Community

INCREASED ACCESS: DEMONSTRATED BY UTILIZATION & TIMELINESS



28% Increase in usage of four HCBS waivers² from July 2020 to July 2023

Investments in creating an online application process and in marketing campaigns have led to increased awareness and utilization of waiver services. Initiatives focused on building provider and workforce capacity have also enabled this increase.



Expedited Waiver Eligibility (EWE) Pilot Results

From Oct 2020 to Sept 2023, there have been over 7,000 EWE applicants, and over 4,500 or 64.5% received a level of care determination in less than 2 days.

FSSA's investments ensure high quality home and community-based services by advancing self direction and individual choice, as well as increasing provider capacity.



\$1M+ directed to support providers in meeting HCBS Settings Rule, promoting personal choice and accessibility through installation of privacy measures



16,000+ individuals to improve nutrition services for Older Hoosiers



\$8M+ directed to support provider training in self-advocacy supports, LifeCourse framework, and person-centered approach



Mental Health Services

The Division of Mental Health & Addiction (DMHA) is responsibly leveraging BLG funds to enhance the quality and capacity of mental health and addiction prevention, treatment, and recovery services.

Investments Enhance Mental Health Services in Indiana

Workforce Recruitment and Retention Innovation Grant Program

Over \$14M will be awarded to 18 grantees carrying out a variety of programming to promote innovative, collaborative, and sustainable responses to behavioral health workforce challenges, with a strong focus on improving care access, continuity, and quality in Indiana.

Change the Frequency aims to provide Indiana families with accessible tools and resources to support mental wellness. From Jan - Jun 2023 its webpages had over 4,000 pageviews.

The Believe in You campaign aims to support Hoosier youth in building a stronger sense of self and includes resources addressing risk areas, which community groups engaging youth are invited to adopt. Nearly 29,000 youth are served through groups connected with Believe in You.

DMHA is expanding the **Certified Community Behavioral Health Clinic (CCBHC) model** statewide to transform the behavioral health system to provide a **comprehensive range of mental health & substance use services for anyone seeking them**. DMHA is targeting federal investments in building **Crisis Response capacity**, an integral part of CCBHC's future state and critical to support providers transition to CCBHC. Addressing **behavioral health workforce challenges** is an essential part of this development.

Building Out the 988 Crisis Response System



>90% In-State answer rate of the 988 call line calls, which has been consistently reached for 8 consecutive months.

- The 988 Telephony System has completed its statewide rollout
- The software platform that will connect all providers in the 988 Crisis Response System is being rolled out first to the 988 Call Centers using a multiphase, iterative approach
