#### **Letter from Christing**

## Primary role of a First Steps provider is to work with and support caregivers

Dear Colleagues and Families,

Happy New Year!

Over the course of the past 18 months, much of the professional development endorsed by the state and provided by Indiana University's Indiana Institute on Disability and Community's Early Childhood Center has focused on early intervention best practices. Through these training opportunities many questions have emerged. I will attempt to address questions in each newsletter throughout 2019.

## How does the state office feel about providers billing for time that was spent on family education activities?

While family education or "family training and support" is a distinct, reimbursable service under First Steps, what First Steps has been focusing on through the Home Visiting Series is reframing the concept of "direct child treatment" as something that includes family coaching and support. It is the position of First Steps that the provision of direct child treatment should

incorporate family and caregiver coaching, and the service as a whole is billed as "direct child treatment."

In December, we hosted a webinar featuring Dr. Robin McWilliam on routines-based early intervention and supporting young children and their families. If you missed it, you can find it on Training Central. I encourage you to seek it out; it is well worth your time. First Steps is promoting this evidence-based practice and believes that children make progress on their outcomes when early intervention professionals provide support and



resources to the child's family and/or caregivers which promote child development through familiar learning opportunities and experiences.

The primary role of the First Steps provider within early intervention is to work directly with, as well as support, family and caregivers. Children are more likely to demonstrate outcome attainment when we coach/scaffold skills in parents and caregivers so they can scaffold skills in their children. Dr. McWilliam has stated, "Therapy and instruction are not golf lessons—children cannot transfer skills well from one learning setting to everyday life." This emphasizes the concept that intervention actually takes place between specialist/therapist visits.

I recently came across this link to an early intervention blog in my research of best practices. Changes in philosophies and approaches can be difficult, take time to master, and require practice and support. We hope to continue to provide all of these over the course of 2019.



## Sharing the Joys of Working with Our First Steps Families

#### Outreach Manager Making Connections with Institutions of Higher Ed

First Steps Outreach Manager Connie Young has been busy making connections with institutions of higher education around the state. In an effort to increase recruitment of providers, Connie has created a Powerpoint to share with university students. The presentation includes the mission and vision of First Steps, an overview of what federal Part C services are and what they look like in the state of Indiana, current data, and our processes, from referral to eligibility and Indiana First Steps program development to ongoing services. Her presentations include a description of career possibilities and how to contact systems point of entries and provider agencies for further information.

Connie has formed relationships with the Indiana State, Ball State, Purdue, Purdue-Fort Wayne and Martin Universities. She is currently collaborating with IUPUI, IU-South Bend, Purdue Northwest



and IU-Kokomo. These connections are helping to provide an opportunity for First Steps to meet with university professors and students in sharing the incredible experiences and joys of home visiting and working with our First Steps families. We are hopeful that this outreach will lead to successful recruitment of new early intervention providers to meet our growing list of referrals.

#### The Puzzle of Deaf-Blindness

#### You Are a Critical Piece

The Indiana Deaf-Blind Services Project is a federallyfunded grant from the U.S. Department of Education. The project provides technical assistance, training and support for children and young adults who have a combined vision and hearing loss, their families, and educators who work with these individuals.

Macie was born prematurely at 23 weeks and weighed 1 lb., 4 oz. She spent her first three months in the hospital. She did not pass the newborn hearing screening test and she has no vision in her left eye. Macie has just started to receive intervention from her First Steps team to help her learn and grow.

Meet Josh Josh is 6 months old. Josh has CHARGE syndrome which affects his heart, his hearing and vision, and causes blockages in his nasal passages. Josh's First Steps team is working hard to design his program to meet all of his multiple developmental and health needs.



Just knowing that each of these three children has a vision and hearing loss is not enough. In addition to the First Steps intervention they already receive, each of these young children also should be reported as deaf-blind to the Indiana Deaf-Blind Services Project for additional support and resources.

Why? Think about how most of us learn about the world; it is through our use of vision and hearing. Sensory abilities (smell, taste, hearing, sight and touch) begin in utero, and it is in the first months of life that a baby begins to organize sensory information. Hearing and vision are our strongest learning senses; they are the reinforcers for physical movement, cognitive, communicative and social connections. When babies have limited or no vision and hearing, the combined effect significantly limits the child's development of cognition and communication as well as the ability to be an active participant in everyday learning activities.

What can you do? Currently, in Indiana, there only are three children (birth through 2) who are reported to the Indiana Deaf-Blind Project as having a vision and hearing impairment. There should be 25–30 infants and toddlers on the Indiana Deaf-Blind Census.

In early March, when you receive a letter requesting your support in identifying infants and toddlers with combined vision and hearing losses in your area, please review the records for each of the children you serve. Does the child have a syndrome that includes vision and hearing loss (there are more than 80 syndromes linked to deaf-blindness)? Was the baby born prematurely? Was the baby exposed to maternal infections (drugs and alcohol)? Were there birth complications? Do you see words in their records like multiple disabilities, prematurity, anoxia, asphyxia, cerebral hemorrhage, cerebral palsy, meningitis or fetal alcohol syndrome? Any of these words are "red flags" that can signal

both vision and hearing issues.

Once referred, the Indiana Deaf-Blind Services Project can work with the First Steps team to help develop specific communication activities, environmental accommodations and systematic teaching strategies to address what are simple concepts and skills that can be missed or misunderstood in the absence of vision and hearing. Please help us better serve these young children during their critical early learning years when learning through their senses of vision and hearing is so critical.

Need help? Contact <u>Lisa Poff</u> at the <u>Indiana Deaf-Blind Services Project</u>. She can answer your questions about referring infants and toddlers to the project. Just know that prompt referral to early intervention services with personnel trained to best address deaf-blindness will have a profound and positive impact on the child's development.
