Dear Stakeholders,

As I prepared to write to you in this July 2020 newsletter, FSSA Secretary Dr. Sullivan's weekly staff email "Broken Pieces" popped into my inbox. In the email was the letter below from Dr. Sullivan and DCS Director Stigdon; a profound message I thought we all need to hear.

And How Are the Children?

Africa's Masai warriors greet each other with the phrase "Kasserian Ingera," which translates to, "And how are the children?" This greeting underscores the importance of children's well-being as a marker of success in their community. The traditional response translates to "All the children are well."

As we assess the ongoing COVID-19 response, reopening and recovery plans of our states, we need to move children to the top of the list of considerations. As clinicians, and as moms, we felt a huge sense of relief when early data suggested that the novel coronavirus was less severe in children and when we didn't see a large volume of critically ill children in our hospitals.

However, children are not completely immune from the physical, economic or social effects of COVID-19, and without specific attention and strategy, the well-being of kids will be the ultimate lagging indicator of our collective success or failure. In fact, the recent global demographic shift of infection to younger people indicates we may already be behind.

Even more profound are the social impacts children feel when fragile support systems are disrupted. This pandemic has put that fragility on full display. Dr. Sullivan was honored to represent Indiana by testifying at a recent congressional hearing about our state's efforts to support child care services during the pandemic to keep them available for essential workers, while protecting children, families and child care employees.

Rolling out the new Indiana First Steps branding

Modernized identity to align with our mission, vision and values

Over the past two years, First Steps has been working to update its child find and referral system in order to develop a more consistent statewide network. As part

of this work, First Steps found it important to refresh its brand. We are very excited to unveil our new Indiana First Steps logo! As you may know, the previous First Steps logo has been around for nearly three decades and, while we have fond feelings for it, we recognize that as an early intervention program it was necessary to modernize our brand identity to align with First Steps' mission, vision and values.

New Early Intervention technology solution

In early 2021, First Steps will be launching a new data management system designed specifically to support early intervention processes across the state. The new system is called Early Intervention - Hub and will replace iSPOE, PAM and other systems currently used to support families, service coordinators and on-going providers. El-Hub users will be able to collect and maintain child and family information from referral to transition, including logging service hours, submitting claims and receiving payments for services. Providers will also be able to manage their enrollment and credentialing. The goal is for EI-Hub to fully and efficiently support agencies and providers as they continue to help children and families connect with essential services and resources that are available to them.

PCG continues to work with First Steps personnel and stakeholders to discuss specific design, functionality and roles associated with El-Hub. The collected feedback will be incorporated into the new system's features, and implementation. We look forward to sharing more specifics and benefits of El-Hub with you over the next few months!

Thank you to everyone who completed the recent survey on change readiness. Your responses will be used to guide the ongoing development of the implementation and training activities associated with the new system. Stay tuned for additional communications about upcoming events and focus groups. We understand that a new system will involve significant changes for all First Steps stakeholders. To make the transition to EI-Hub smooth and successful, we are committed to collaborating with you to help you succeed. Family expectations study

IU conducting research on families of young children with disabilities

The Early Childhood Center at the Indiana Institute on Disability in the Community at Indiana University is conducting a research study on family expectations. This study is specifically focused on families of young children with disabilities. There is a substantial body of research showing a strong association between family expectations for children with disabilities and later

outcomes (e.g., employment, college, independent living).

Surprisingly, there have been very few studies examining the expectations families have of their young

children with disabilities. The study will explore how families develop expectations, and who and what have influenced them. As a direct service provider in the state's early intervention system, you work with families at a critical time in their young child's life and fostering high expectations early could have an impact across the life course.

IU researchers want to talk to families of young children with disabilities. Recruitment has been slow due to COVID-19 but we are actively seeking families and providers to participate in the study. The entire process can be done virtually and consists of a one-hour interview and a few brief questionnaires.

How can you help? Share information about the

check for participating.

have heard of the SS-OO-PP-RR, a framework for home-visiting that includes Setting the Stage, Observation and Opportunities to embed, Problem-Solving and Planning, and Reflection and Review. You may find these resources on our website under the COVID-19 policies information.

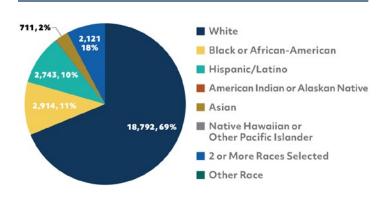

Understanding Part C federal indicators

Federal indicator 7: The 45-day timeline

As part of the annual performance report, we must identify the percentage of eligible infants and toddlers with an individualized family service plans for whom an evaluation and assessment and an initial IFSP meeting were conducted within the 45-day timeline.

The target for this indicator as set by the Office of Special Education Programs is 100%. Our goal is to complete the initial evaluation and assessment, determine eligibility,

and write the IFSP within 45 calendar days from the child's date of referral 100% of the time. Day one is the date the referral was received by First Steps. As reported in FFY 2018, First Steps met this requirement 94.36% of the time. While close to meeting our target, we still have room to improve.

Here is how First Steps personnel can collaborate so eligible children receive services as soon as possible and we can meet this target.

It all starts with data entry. It is imperative that data entry personnel enter the referral information as soon as possible. It is important to verify that the contact information for the child's parent/guardian is correct to ensure the service coordinator can contact the family. It is also important that all intake, evaluation and assessment, eligibility, and IFSP information is entered into the system in a timely manner so that reports for this indicator are correct.

Service coordinators need to make contact with families as soon as the referral is assigned. Best practice is to contact the family within two business days of receiving the

referral. The SC should make three attempts to contact the family on three separate days in order to schedule the intake meeting. After the second failed attempt to make contact, a letter may be sent to the family requesting they contact the SC within 10 days in order to proceed. The SC should make a third and final attempt to contact the family. All attempts to contact the family must be documented as part of the child's early intervention record.

The intake meeting should be completed within two weeks of the referral. In the essence of time, it is recommended that the assessment team scheduler be contacted during the intake meeting or shortly thereafter, in order to schedule the evaluation and assessment. If possible, it is also helpful to set the date for the IFSP meeting during the intake meeting.

It is vital that all First Steps personnel work together in

order to identify the days and times that are available to schedule appointments. If the evaluation and assessment was not scheduled during the intake meeting, best practice is to contact the family within two business days of that meeting. The scheduler should make three attempts on three separate days to contact the family in order to schedule the assessment. After the second failed attempt to contact the family, the scheduler should contact the SC to verify the contact information. In the event that the family cannot be reached via phone/email, a letter may be sent to the family requesting they contact the SC within ten days in order to proceed. The scheduler should make a third and final attempt to contact the family by phone or email. Again, all attempts to contact the family must be documented as part of the child's early intervention record. It is recommended that the family be reminded of their appointments to ensure they are aware and prepared. In the event that the evaluation and assessment appointment is cancelled and must be rescheduled, it is important to

> let the SC know as soon as possible in case the IFSP meeting needs to be changed as well.
