All,

This is in regard to the proposed rule (LSA 13-422) implementing various Medicaid cost reductions expected to be effective **January 1, 2014**. At present, we are on track to have the rule in place to meet that deadline but the timeline is very tight. Attached is notification to State Budget of our public hearing to be held on **October 31, 2013**, but we have not yet received a response from State Budget on our family impact statement. The Attorney General's office has informed us that they will not approve any rule that does not receive a response on or before seven (7) days before the public hearing.

As such, we will need to delay implementation of these cost reductions by a minimum of thirty (30) days if we do not get a response on or before **October 24, 2013**. Attached is an example of a response to our family impact statement for another rule. We are expecting something similar for this rule. Attached is a copy of the FSSA's Family Impact Statement for your convenience.
