9222/3 Chondrosarcoma, grade 1 (Behavior change. Reportable 1/1/2022 forward)

8144/2 Intestinal-type adenoma, high grade (C160 – C166, C168-C169, C170-C173, C178-C179)

8213/3 Serrated dysplasia, high grade (C160 – C166, C168-C169, C170-C173, C178-C179)

8483/3 Adenocarcinoma, HPV-associated C530-C531, C538-C539)

Not Reportable 2022 and Forward (behavior change):
