Children's Special Health Care Services





What is CSHCS?

Child Special Health Care Services (CSHCS) provides supplemental medical coverage to help families of children (birth to 21 years of age) who have serious, chronic medical conditions and meet the program's financial and medical criteria, pay for treatment related to their child's condition.

Financial Eligibility Families with a pre-tax income no greater

Families with a pre-tax income no greater than 250% of the federal poverty level may be eligible. The poverty level changes annually. Visit **cshcs.IN.gov** for financial eligibility information.

Medical Eligibility

CSHCS is designed to help Hoosier children with severe chronic medical conditions that:

- Have lasted or are expected to last at least two years
- Will produce disability, disfigurement or limit the child's ability to function
- Requires special diet or devices
- Would produce a chronic disabling physical condition without treatment

Eligible Conditions

- Apnea
- Arthritis
- Asthma (severe)
- Autism
- Cerebral palsy
- Chronic anemia
- Chromosomal disorders
- Chronic pulmonary disease
- Cleft lip and/or palate
- Congenital or acquired developmental deformities
- · Congenital Heart Disease or Arrhythmia
- Cystic fibrosis (lifetime medical eligibility)
- Endocrine deficiencies
- Hydrocephalus
- Inflammatory bowel disease
- Inborn errors of metabolism
- Myelodysplasia or spinal chord dysfunction
- · Neuromuscular dysfunction
- Oncologic disorders
- Profound bilateral hearing loss
- Renal disease
- Seizure disorder
- Severe hemophilia

This list is not all inclusive. All diagnoses are subject to CSHCS rules and requirements.

Apply

The CSHCS application process is broken down into three steps:

- 1. Determine eligibility and apply for Medicaid
- 2. Prepare required documents:
 - · Proof of residence
 - Child's birth certificate
 - Health insurance information
 - Proof of household income
 - Proof of Medicaid application
- 2. Apply using the enrollment packet, or by contacting one of our partners.
