Re: Approval renewal of the *Design and Installation Manual for the Infiltrator ATL™ System in Indiana*, March, 2015, for use in residential and commercial on-site sewage systems

The *Design and Installation Manual for the Infiltrator ATL™ System in Indiana* approval is renewed by the Indiana State Department of Health (department), under the provisions of 410 IAC 6-8.3-52(h), 410 IAC 6-10.1-49(h) and the *Indiana Standards for Infiltrator ATL Systems* published by the department on August 19, 2014, revised several times with the latest renewal on April 13, 2020. The final revision to this manual bears the publication date of March, 2015.

This approval renewal is for the use of the Infiltrator ATL™ System in individual residential and commercial onsite sewage systems. This approval renewal is effective the 1st day of April, 2021 and expires and is subject to renewal by the department no later than the 1st day of April, 2022. This approval is subject to the conditions listed below:

- I. Infiltrator Systems, Inc. is required to:
 - a) Certify manufacturers, distributors, designers, installers and service providers;
 - b) Submit to the department a list of all certified installers, distributors, service providers and manufacturers for the State of Indiana on a quarterly basis the first year and annually after that; and notify the department immediately of the removal of any certified installer, distributor, service providers or manufacturer;
 - c) Submit for review and approval of the department any proposed changes to any system component or the *Design and Installation Manual for the Infiltrator ATL™ System in Indiana* prior to implementation of the changes;
 - d) Notify the department of any scheduled training event at least 10 working days prior to the event;
 - e) Provide on-going consultation to health department staffs, designers, installers, and service providers;
 - f) Submit to the department on a quarterly basis the installation of any onsite sewage system installed that includes an Infiltrator ATL System using a data format provided by the department.

II. The Infiltrator ATL System is subject to:

To **promote**, **protect**, and **improve** the health and safety of all Hoosiers.



- a) The applicable provisions of ISDH Rules 410 IAC 6-8.3 and 410 IAC 6-10.1;
- b) Receiving and dispersing only domestic and residential strength wastewater;
- c) The *Design and Installation Manual for the Infiltrator ATL™ System in Indiana*, March, 2015;
- d) The Infiltrator Water Technologies, Inc., September 30, 2019 memorandum outlining Dosing Volume Recommendations and the 4-inch diameter allowance for the observation ports required in ATL systems.

III. The Infiltrator ATL System manufacturer, designer, distributor, installer, and service provider is subject to:

- a) Infiltrator Systems, Inc. Certification;
- b) Maintaining a status of good standing with Infiltrator Systems, Inc.

This approval may be revoked or modified by the department for non-compliance, or if it is documented that it would not be in the best interests of public health for approvals to continue.

If you wish to request administrative review of this *Approval* pursuant to Indiana Code 4-21.5-3-5, you must file a petition for review within fifteen (15) days after this *Approval* is received.

The petition for review must be in writing and must include facts demonstrating that:

- The petitioner is a person to whom the *Approval* is specifically directed;
- The petitioner is aggrieved or adversely affected by the *Approval*; or
- The petitioner is entitled to review under any law.

If the petition for review is not filed timely, this *Approval* becomes FINAL. Any petition for review and petition for stay of effectiveness must be submitted in writing to:
