# **Division Introduction & Newsletter Purpose**

IDOH established the Home & Community Based Care (HCBC) division in September 2021. The focus of the division is operational improvements, including establishing working leaders, enhancing surveyor training and updating the Informal Dispute Resolution (IDR) process for home health providers. The division is also engaged with Indiana Family and Social Services Administration (FSSA) and the Bowen Center on work around direct care/direct support workforce and its impact on home health and personal care service agencies.
