Use of face shields or protective eyewear / goggles

To align with updated Centers for Disease Control and Prevention guidelines, Indiana Department of Health is now recommending the use of eye protection as a standard safety measure to protect long-term care healthcare personnel (HCP) who provide essential direct care within 6 feet of the resident, especially when doing procedures that lead to sprays and splashes.

This includes the delivery of care for non-COVID residents in facilities with 1 or more symptomatic and/or COVID positive residents, and those who are quarantined in COVID positive, symptomatic, or quarantined residents who are already in transmission-based precautions – Droplet – Contact. For facilities without COVID symptomatic and /or COVID positive residents, this is up to HCP should they wish to use this added protection.

CMP – Communicative Technology Project Request

The Indiana Department of Health, Division of Long Term Care has approved approximately 340 facility applications for the Civil Money Penalty (CMP) COVID-19 Communicative Technology Project. This

project enables nursing homes to purchase communicative devices and accessories so residents can have virtual social and telehealth visits. The COVID-19 pandemic has been extremely difficult and stressful for all LTC residents and staff. These devices will allow for communication and virtual visits with families and healthcare providers.

New Reporting Mechanism for Lab Results Next Week

Next week, the state health department will begin collecting all positive and negative COVID-19 lab results from the CMS-delivered point-of-care antigen testing machines (i.e., Quidel Sofia SARA Antigen FIA, BD Veritor System for Rapid Detection of SARS- CoV-2). This reporting through a second, additional Redcap form will satisfy CLIA reporting requirements, and will ensure that the state health department of captures laboratory information in a timely manner.

The new mechanism is not quite ready but will be soon, and we expect to provide details and instructions early next week. Until that happens, please hold all point-of-care lab results to be reported after the new mechanism is up and running. (Please note: This hold request applies only to reporting of lab results. Please continue to report your total COVID-19 resident and staff events in the existing REDCap Long Term Care COVID-19 Reporting form, including those who test positive from your point-of-care machines.)

From the document linked above: "CMS will temporarily exercise enforcement discretion for the duration of the COVID-19 public health emergency under CLIA for the use of SARS-CoV-2 POC antigen tests on asymptomatic individuals. Specifically, CMS will not cite facilities with a CLIA Certificate of Waiver when SARS-CoV-2 POC antigen tests are performed on asymptomatic individuals, as described in the FDA FAQ."
