 - 81 LHDs responded. Minimum of 4500 MRFEs in the state, not counting LHDs that did not respond.
 - 23 LHDs post inspection reports online.
 - 54 LHDs utilize a single tier permit schedule.
- Discussion of proposed amendments to HB 1577.

- Clarification of inspection requirements and LHD authority and obligation to inspect MRFEs that did not originate from their county.
- Modifications to the fee structure for smaller MRFEs. Modification of remittance requirement from monthly to annually.
- Creation of a limited duration license.
- Establishment of revocation authority and system.
 - Possible differentiation between suspension of a license and revocation of a license.
- Clarification of the license period. Is it 12 months from date of application or calendar year?
- Add an obligation to the owner of the MRFE to ensure that all fines are paid before renewing their license, or paid within 10 days, whichever is sooner.
- Add an obligation for a MRFE to comply with all local laws.
- Add an obligation for a MRFE to notify an LHD of their intent to operate in the jurisdiction.
- Discuss implementation and system for new statewide license.
 - Clarification needed on whether plan review fees are separate from the license fees under HB 1577.
 - Can data be exported from the proposed system?
 - Can the LHD be notified if there is a change in the commissary?
 - o Will the system be able to create a new profile per vehicle?
