Conference Topic: "Managing Incontinence Care"

Healthcare leaders on incontinence care will provide you with the tools and resources to improve your incontinence care program for your residents. It is our goal to assist long term care facilities to have excellent incontinence care programs. The conference will be an important opportunity to have dialogue on incontinence issues in long term care and improving the health of Hoosiers.

About the Leadership Conference

The Indiana Long Term Care Leadership Conference is an initiative of the Indiana State Department of Health (ISDH). The ISDH plans two Leadership Conferences per year – one in the spring and one in the fall. Each conference is a one-day conference focusing primarily on a single issue.

The Leadership Conferences which began in June, 2007 have grown in attendance from 720 participants to over 1000 participants including the ISDH long term care surveyors. Attendees have been treated to outstanding presentations on falls management, reduction of pressure ulcers, behavior management and reduction of restraints, emergency preparedness planning, and were provided with a variety of educational and practical resources on all these topics.

The conferences are intended to bring together statewide healthcare leaders to promote important quality of care issues. This conference will include providers, surveyors, healthcare organizations, and individuals with significant interests in

long term care. Each conference will:

- Provide updates on the long term care licensing and certification program
- Discuss quality of care initiatives and programs
- Discuss an ongoing regulatory issue with a goal of clarifying regulations and providing improved guidance on issues
- Provide best practices on quality of care
- Provide an opportunity for increased interaction and awareness

Invited Participants

The ISDH invites each comprehensive care facility (nursing home) to send two representatives to the conference. Each facility may select the individuals attending the conference on behalf of their facility. The ISDH recommends individuals such as the facility administrator, director of nursing, or compliance officer. Corporate offices of facilities are also invited to send appropriate representatives. The ISDH will also be inviting selected professional organizations and individuals to attend the conference. Invited organizations will include the Alzheimer's Association of Greater Indiana, HealthCare Excel, Hoosier Owners and Providers for the Elderly, Indiana Health Care Association, Indiana Hospital Association, Indiana Homes and Services for the Aging, Indiana Assisted Living Federation, Indiana Ombudsman, patient safety coalitions and centers, and United Senior Action. The ISDH will also be inviting academic and legislative partners. All ISDH long term care surveyors will be attending.

Speaker: Terry Whitson, Assistant Commissioner, Indiana State Department of Health

8:45 – 10:00 Medical Aspects of Urinary Incontinence

Speaker: Martina F. Mutone, MD, FACOG, Urology of Indiana and Clinical Assistant Professor at Indiana University School of Medicine

Topic: Dr. Mutone will discuss the anatomy and physiology of urinary incontinence. She will also cover risk factors and evaluation and management of urinary incontinence.

10:15 – 11:30 The Persistent Stigma: Urinary and Fecal Incontinence in the Nursing Home

Speaker: Mikel Gray, PhD, FNP, PNP, CUNP, CCN, FAAN, Nurse Practitioner and Professor, Department of Urology, University of Virginia

Topic: Urinary and fecal incontinence affect between 50% and 65% of nursing home residents, including many who suffer double (urinary and fecal) incontinence. Research demonstrates that incontinence ranks second only to cognitive decline as a predictor of impaired quality of life among nursing home residents. Despite its devastating effect on quality of life, urinary incontinence was rated as having less impact on residents' quality of life than dementia, falls, unintended weight loss, or pain. Dr. Gray's presentation will review the epidemiology of urinary and fecal incontinence in nursing home residents and explore its impact on quality of life.

12:30 – 2:00 Management of Urinary Incontinence, Urinary Tract Infections, and Catheters

Speaker: Jeri Ann Lundgren, RN, CWS, CWCN, Director of Wound & Continence Management, Pathway Health Services, Inc.

Topic: Ms. Lundgren will discuss the assessment and evaluation of urinary incontinence, identifying types of incontinence and the treatment options. She will also explain the medical justification of indwelling catheters in relation to F315.

Topic: Ms. Bartle will discuss the challenges of meeting F315 in managing incontinence care in long term care facilities.
