Welcome Remarks Kristina Box, MD, FACOG State Health Commissioner

Dr. Box was named Indiana State Health Commissioner by Governor Eric J. Holcomb on September 18, 2017. She brings to the role a passion for improving the health of Hoosiers, beginning before birth.

Dr. Box has been a practicing obstetrician and gynecologist in Indianapolis for 30 years. She served on the Indiana Perinatal Quality Improvement Collaborative (IPQIC), an advisory council to the Indiana Department of Health that is comprised of more than 300 statewide community professionals working to reduce infant mortality. Her work with IPQIC included serving on a state task force to address neonatal abstinence syndrome (NAS), which established standards for the diagnosis of NAS and developed a hospital study to determine the prevalence of drug exposed newborns.

Dr. Box earned her undergraduate degree at Indiana University in Bloomington and her medical doctorate at Indiana University School of Medicine in Indianapolis.

She and her husband of 35 years, David, a retired ophthalmologist, live in Indianapolis. They have four adult children.

Dr. Allen grew up on a farm in Iowa and did his undergraduate at the University of Iowa. He stayed at Iowa for MD/PhD training with his doctoral work in Microbiology. He returned to the University of Iowa for fellowship training in Infectious Diseases before joining their faculty.

Dr. Allen moved to Indianapolis and joined the Indiana University School of Medicine's Division of Infectious Diseases in 2000. He later became Chief of Medicine at the Roudebush Veterans Affairs Medical Center and then moved to the role of Vice Chairman for Education in the Department of Medicine. He currently serves as Senior Associate Dean for Medical Student Education and the D. Craig Brater Scholar in Professionalism, as well as Associate Professor of Clinical Medicine and Infectious Diseases for IUSM. His duties include oversight

	and management of the curriculum and student support delivered throughout the statewide IUSM system.
	Dr. Allen serves as the Medical Consultant for the Tuberculosis Program for the Indiana Department of Health and practices in ID and HIV care at the Indianapolis VAMC. He is an avid bicyclist, Habitat for Humanity volunteer, and enjoys traveling with his wife Anne.

Pam Pontones has served at the Indiana Department of Health since 1990. She began her career as a microbiologist in the IDOH Laboratory and transitioned to the Epidemiology Resource Center in 1999. Since 2009, Pam has served as State Epidemiologist overseeing programs including infectious disease epidemiology, vectorborne and zoonotic diseases, syndromic surveillance, Behavioral Risk Factor Surveillance System, and public health geographics. She also serves as an agency spokesperson for infectious diseases and other health issues. In February 2017, she was appointed deputy state health commissioner, assuming oversight for the Office of Public Health Performance Management (OPHPM) and the agency's quality improvement efforts.

Pam is an adjunct faculty member for the IU Richard M. Fairbanks School of Public Health and has been a member of the Council of State and Territorial Epidemiologists since 2010. She was a scholar in the 2010 National Public Health Leadership Institute and a fellow in the 2001 Mid-America Regional Public Health Leadership Institute. She graduated cum laude from Indiana University Bloomington with a BA in biology and minor in journalism and holds a MA in microbiology from IU.
