The University of Southern Indiana (USI) Geriatrics Workforce Enhancement Program (GWEP) has established a nursing home consortium, AIM (Advance, Improve, Move!), designed to support nursing home leaders with education and innovative opportunities to grow age- and dementia-friendly care.

The AIM Nursing Home Consortium consists of quarterly meetings hosted on Zoom featuring national and regional experts. These meetings provide educational opportunities for nursing home leaders and resources designed to benefit both the nursing home staff and residents. - Topics covered: human dignity for all persons, recognizing abuse and neglect, causes of abuse and neglect of residents, training for staff that prevents stressors, abuse by other residents, abuse by visitors/family members, preventing abuse and neglect and intervening, reporting abuse and neglect, and mechanisms to administratively monitor for potential abuse.

Each course offers long-term care specific examples. CEUs are available through IDOH for administrators and social workers.
