LTC Facility Employee COVID-19 Testing Initiative – August 2020

The ISDH in partnership with Probari, Inc. is sponsoring a statewide LTC Facility Employee COVID-19 Testing Initiative. Probari will provide communication, support and results reporting for this testing initiative. Facilities should expect a phone call from a Probari nurse. The Probari Team will provide the following:

- 1. Outreach calls to confirm dates and provide information
- 2. Phone & email support throughout the program testing period
- 3. Results reporting

LTC Facility Staff COVID-19 Testing Initiative – August 2020 specific information:

- Program dates: 08/12/2020 through 09/10/2020
- ALL skilled nursing facility / nursing facility (SNF/NF) staff will be tested, including contractors working in the facility
- No charge to the facilities
- NO ONSITE TESTING All facilities will perform specimen collection with provided test kits that will be delivered by ISDH
- Specimens will be obtained from anterior nares not nasopharyngeal site
- Specimens will be collected by ISDH and the testing will be completed by partner labs throughout the state
