The Children and Hoosier Immunization Registry Program (CHIRP) is a secure web-based application that works as an immunization registry program designed to permanently store a person's immunization records in electronic format. Requirements & Additional Information

On March 19, 2020, Governor Eric Holcomb issued Executive Order 20-05 in response to the COVID-19 pandemic. This order, and its various extensions, permitted certain unlicensed healthcare practitioners to practice under a temporary license, and established a licensure registry to identify those practitioners who have been issued this temporary license.

To address Indiana's ongoing healthcare needs, this temporary license and the licensure registry were recently incorporated into state law under Indiana Code § 25-1-5.7, after Governor Holcomb signed House Enrolled Act 1003-2022 into law. Under this new law, this temporary license and the licensure registry are effective through the duration of the federal public health emergency concerning COVID-19, declared by the U.S. Department of Health and Human Services. This declaration must be renewed every 90 days, and was last renewed on January 11, 2023.

What does this mean for your emergency registration? Unless otherwise notified by PLA, no action is required to preserve your emergency registration. The emergency registration issued to you under Governor Holcomb's various Executive Orders is identical to the license issued under Indiana Code §25-1-5.7.

PLA anticipates the emergency registry will remain valid until April 11 and anticipates that it will provide approximately 60 days notice before it expires.

If you have questions regarding the duration of your temporary license, please refer to the U.S. Department of Health and Human Services' <u>public health emergency declarations concerning</u> COVID-19.

Reporting Outbreaks

As indicated within the IDOH Long-Term Care Abuse and Incident Reporting Policy, effective Dec. 8, facilities are required to report epidemic outbreaks of at least three residents with the same infection in one defined area (such as hall, unit, neighborhood, street, pod, secured unit, vent unit) in a 48-hour period; or 10% or more of the current building census with the same infection.

The <u>LTC Newsletter 2022-45</u> from Dec. 20, 2022, provides links to the IDOH Infection Prevention Program, which has links to the toolkits. At this time, the influenza toolkit available online still instructs providers to call IDOH to report. While we are waiting for the toolkits to be corrected, providers are reminded that outbreaks should be reported through the <u>Gateway</u> and not called in to IDOH.

As of July 1, 2015, incident reporting by email, fax or voicemail is not accepted. Incident reports, including reporting of communicable diseases and epidemic outbreaks, are to be submitted online via the Survey Report System in the <u>IDOH Gateway</u>. Nursing Home Collaboratives. QSource would like to invite you to a virtual kickoff meeting to reintroduce the nursing home collaboratives in twelve regions throughout Indiana. CMS Memo QSO-23-05-NH

CMS released QSO-23-05-NH on Jan. 18, with updates to the Nursing Home Care Compare website and Five Star Quality Rating System. CMS will conduct audits of schizophrenia coding in the Minimum Data Set data and adjust the Nursing Home Care Compare quality measure star ratings for facilities whose audits reveal inaccurate coding. In addition, to be more transparent, CMS will now display citations under informal dispute on the Nursing Home Care Compare website.
