Removal of DATA Waiver (X-Waiver) Requirement

On Dec. 29, 2022, Congress signed the Consolidated Appropriations Act of 2023, which eliminates the DATA-Waiver program. Previously, practitioners were required to submit a Notice of Intent to prescribe buprenorphine for individuals suffering from opioid use disorder (OUD). With this new provision, all practitioners who have a Drug Enforcement Agency (DEA) registration that includes Schedule III authority can prescribe buprenorphine in their practice if permitted by state law.

This policy reform is significant amidst the United States' opioid epidemic. The DEA strives to increase access to life-saving medications for opioid use disorder, like buprenorphine. The elimination of the X-Waiver will increase accessibility to OUD medications for those in need.

Looking forward, the Providers Clinical Support System (PCSS) will continue to sponsor waiver trainings and sponsor live trainings upon request. Waiver trainings will also continue to be available for practitioners online. The DEA and SAMHSA are also formulating new training requirements for prescribers. These collaborations will streamline PCSS resources for providers and increase access to opioid use disorder medications.

Madison County Syringe Services Program Extended

The syringe services program in Madison County has been extended for two years. Madison County Commissioners unanimously voted to extend the program, administered by Aspire Health Indiana, until March 2, 2025.

According to Julie Folz, director for infectious disease at Aspire, the goal of the program is to prevent the spread of HIV and hepatitis C while providing a safe environment for participants to get referrals about substance use treatment. Intravenous drug users can get new syringes when they return used needles. Madison County ranks seventh in the state in hepatitis C cases and 15th in the state for HIV cases.


