#### **Upstream Prevention Installs 14 NaloxBoxes in Johnson County**

Upstream Prevention is an organization that strives to decrease suicides and address substance use in Johnson County. During downtown Edinburgh's annual Turn the Town Purple event, which memorialized fellow community members who have died from overdose, Upstream Prevention provided doses of naloxone and information about the life-saving drug.

Upstream Prevention is one of Indiana Department of Health's grantees through the IN CARES ECHO program, which focuses on communities experiencing high rates of opioid-related overdose to put community-based solutions in place. This grant, with funding from the Duke Energy Foundation, has provided money for NaloxBoxes. The NaloxBoxes were provided by Overdose Lifeline and have been posted at various locations throughout the county, such as at each of the county's library branches, community corrections and more.



African Americans are overrepresented among drug abusers in the U.S., but they are also more likely to seek treatment for their drug addiction. In 2020, around 7,095 people aged 15 to 24 years died from a drug overdose. Opioids, primarily prescription pain relievers and heroin, are the main driver of overdose deaths. This webinar will explore the most common substance of choice, signs and symptoms of teen substance use and discuss treatment options for this population.
