Survey Date: 09/26/24 Facility Number: 000014 Provider Number: 155039 AIM Number: 100288670 At this PSR survey, The Waters of Peru Skilled Nursing Facility was found compliance with Requirements for Participation in Medicare/Medicaid, 42 CFR Subpart 483.90(a), Life Safety from Fire and the 2012 edition of the National Fire Protection Association (NFPA) 101, Life Safety Code (LSC), Chapter 19, Existing Health Care Occupancies and 410 IAC 16.2. This one-story facility was determined to be of Type II (000) construction and was fully sprinklered. The facility has a fire alarm system with smoke detection in the corridors, areas open to the corridors and battery powered smoke detection in the resident sleeping rooms. The facility has a capacity of 130 and had a census of 38 at the time of this survey. All areas where the residents have customary access were sprinklered.
