Crowe Technology Assessment

IDOH engaged Crowe LLP (Crowe) to assess the laboratory and public health application and data ecosystem as it related to COVID-19. Following are the high-level recommendations:

- IDOH should develop a comprehensive IT and Data Strategic Plan...focused on the next three to five years
- To develop a plan, IDOH should engage internal business users, state agency partners, the broader health community and local health departments
- IDOH should upgrade and/or replace existing business applications and hosting environments to address systems that lack functionality, flexibility and/or have performance challenges

- IDOH has established a team leading a Transformation Initiative program focusing on our IT Applications and Data to move into alignment with our agency's Strategic Plan.

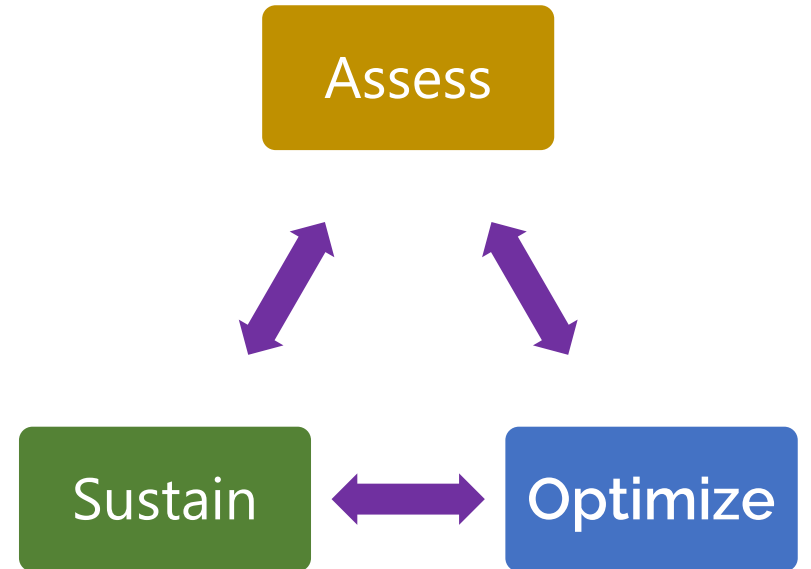

- **Sustain** – We will provide the ability for continuous feedback and improvement so that we evolve and can be looked at as one of the national leaders in our space



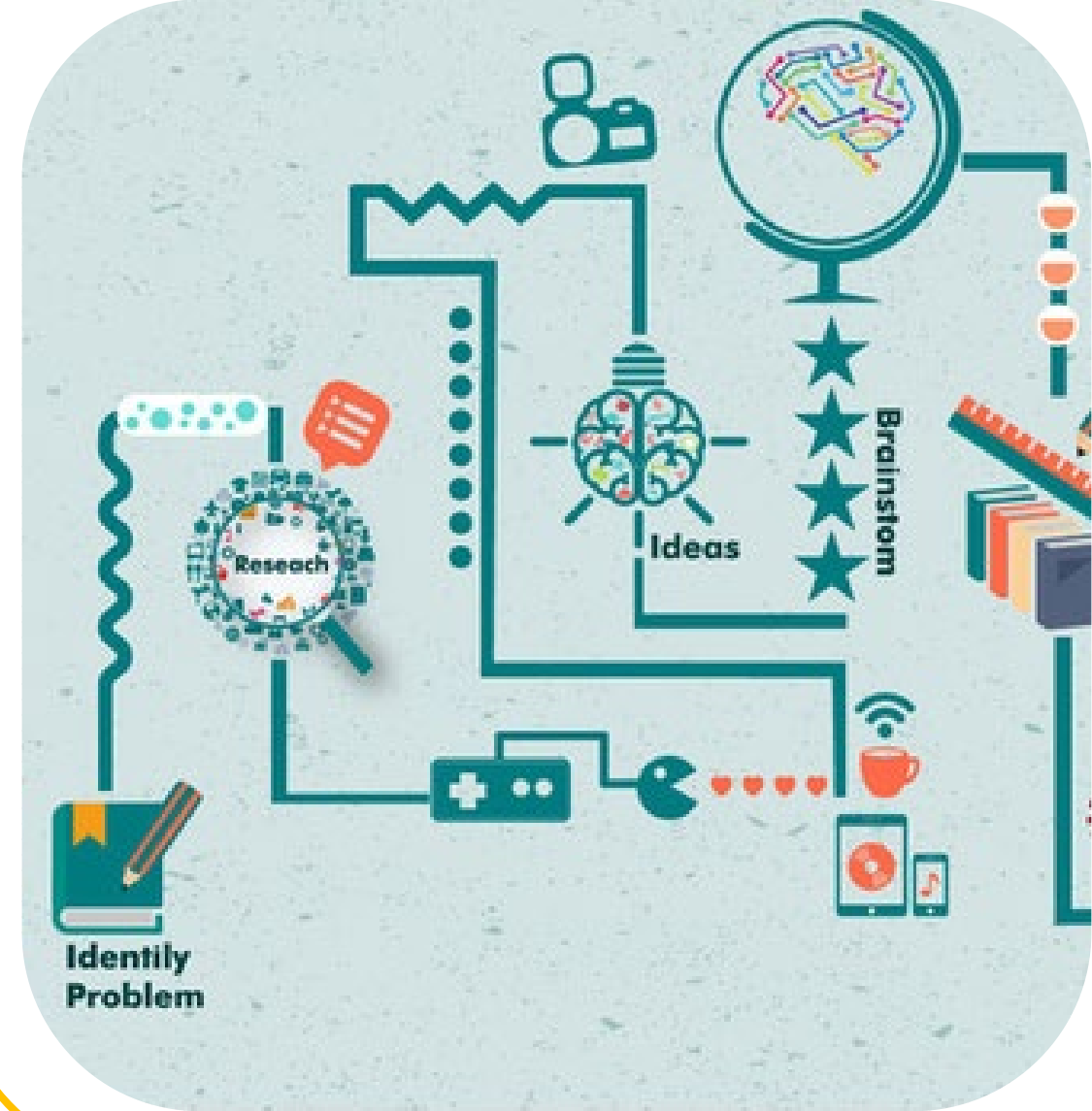
People Outcomes

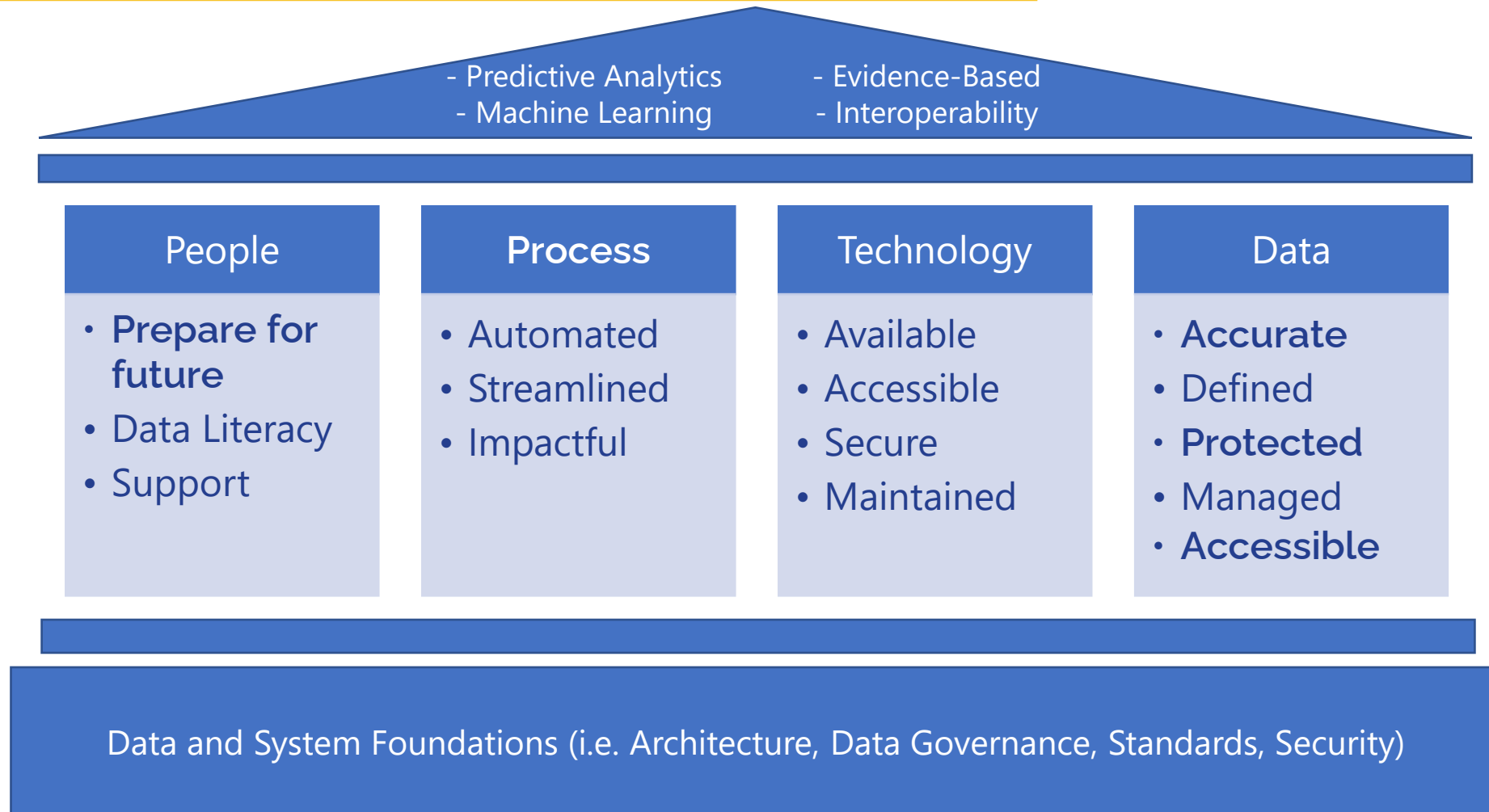

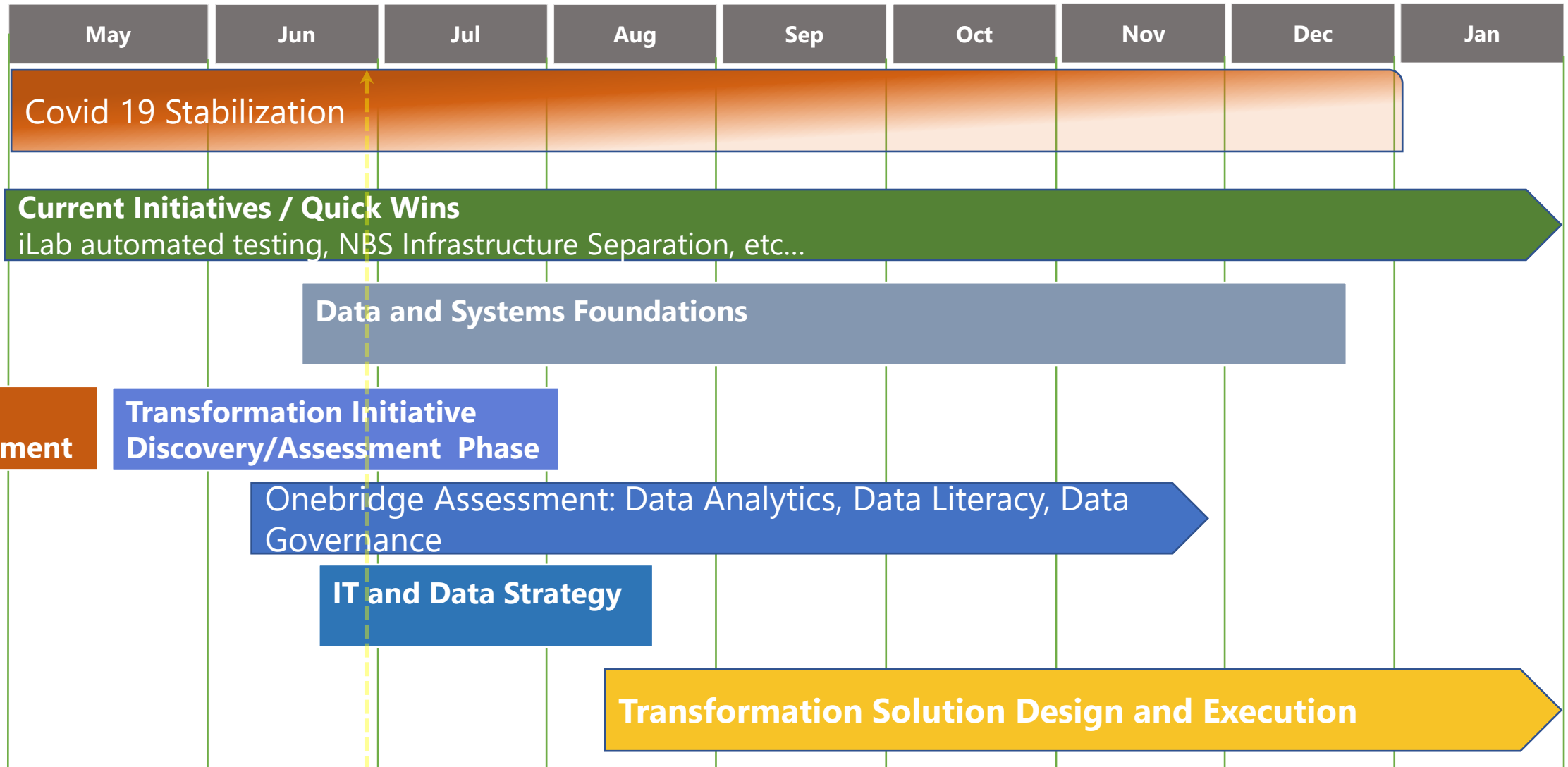
