






Patient Gender Public Health Preparedness District 3




Patient Age Groupings






Primary Payer Mix Public Health Preparedness District 3




Injury Severity Score (ISS) Public Health Preparedness District 3






ICU Length of Stay (Days)




ED Disposition Public Health Preparedness District 3








Hospital Disposition


