## ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 4 - Peter Wrenn fined \$50.00 for failure to drive when programmed.

Race 7 – Inquiry posted looking in to if No. 10 ALEXA made the fair start pole. Video showed that the horse was inside of the pole by the time the remainder of the field was released by the starter. No. 10 ALEXA made an official starter.

Race 10 – Nos. 6 ELHELPSKI and No. 9 SWAN EXPLOSION both first time Lasix. Announcements made via track announcer and tv scroll. Inquiry posted on unofficial third place finisher No. 3 MEADOWBROOK MASTER (Trace Tetrick) for possible violation of the breaking rule in the stretch. Video showed that while off stride the horse was even for five or six strides with eventual second place finisher No. 3 DASHING DANNY (Kyle Wilfong). For violation of the breaking rule – failure to continuously lose ground while on a break – No. 3 DASHING DANNY finished third placed seventh.
