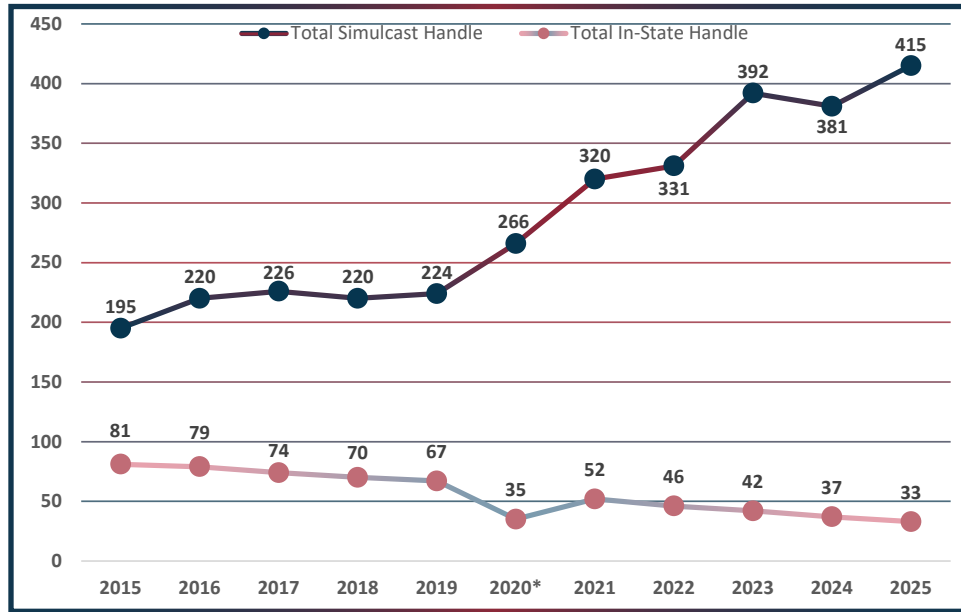

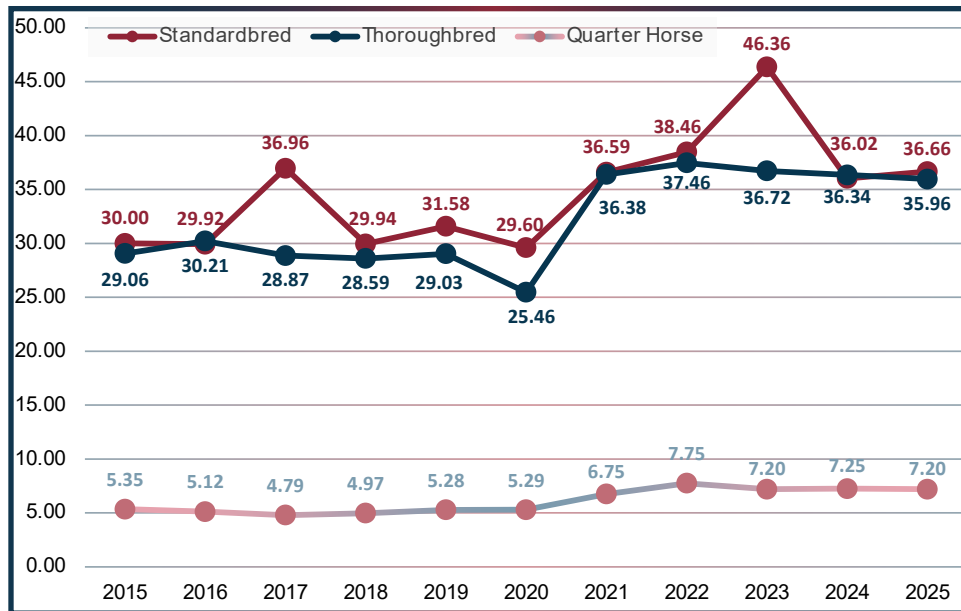
Total Simulcast & In-State Handle

Previous 10 years. Values are in millions of dollars.

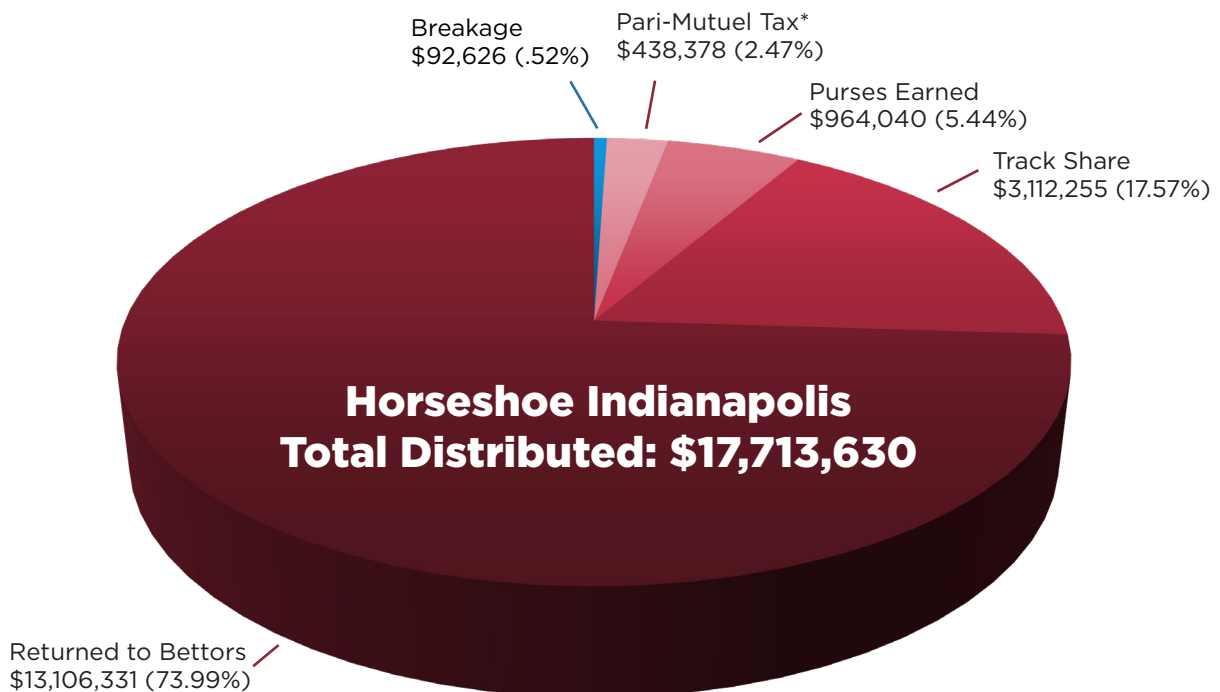
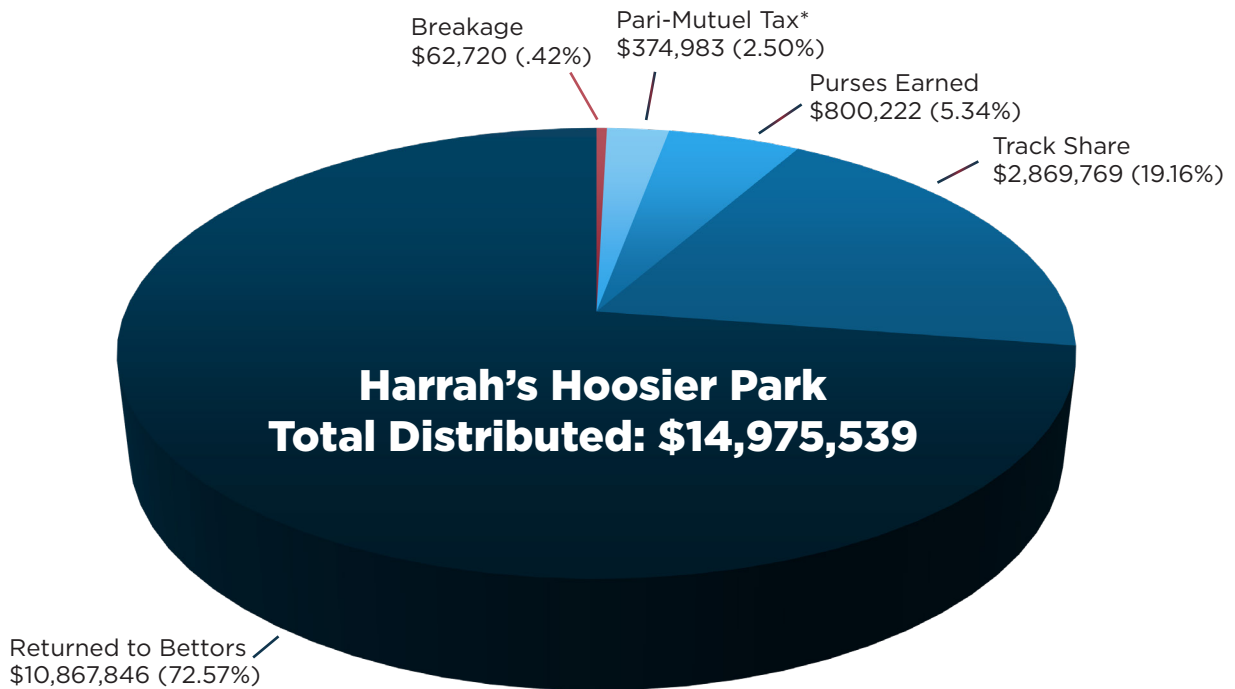

Occupational Licensing

Pursuant to IC 4-31-6 and 71 IAC 5-1-1, all persons participating in pari-mutuel racing under the jurisdiction of the Commission are required to be licensed. The licensing process is the backbone of the Commission's regulatory efforts. Each prospective licensee is fingerprinted.

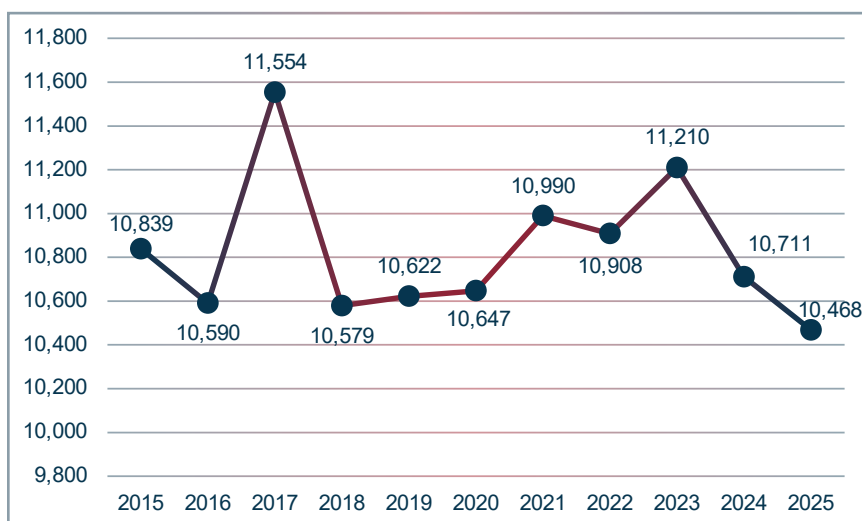
The Federal Bureau of Investigation provides the Commission with criminal histories of all applicants. The Commission may refuse or deny the application for licensure of any person whose criminal or racing violation record is contrary to the public's best interest.

Drug Testing

Pari-mutuel horse racing can succeed as a legitimate major league sport only if its races are perceived by the wagering public to be honest, competitive contests, free from manipulation by humans or drugs. The Commission's drug detection program is one of the nation's most comprehensive and its laboratory, one of the most respected in the racing industry.

The Commission's assessed penalties for equine positives are determined based upon national industry standards set by the ARCI Uniform Classification Guidelines for Foreign Substances and Recommended Penalties Rule.

In 2025 Industrial Laboratory in Denver, Colorado, served as the Commission's primary laboratory for Standardbred and Quarter Horse testing.

Breed Development Programs

Overview

Pursuant to IC 4-31-11, breed development programs were created to promote the breeding of horses while stimulating the agri-business sector of the state's economy. The breed development programs are funded by breakage (the difference in the rounding off of pari-mutuel payoffs), outs (all uncashed tickets) and a percentage of the adjusted gross receipts (AGR) from slot machine wagering at racinos.

Each Breed Development Program has a three-member committee appointed by the Governor whose role is to work with IHRC staff to make recommendations to the IHRC annually regarding the format of these programs for each breed: Quarter Horse, Standardbred and Thoroughbred.

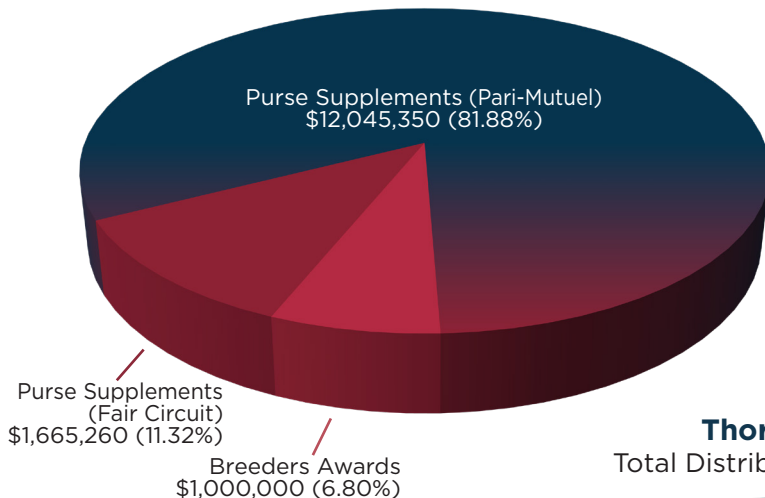

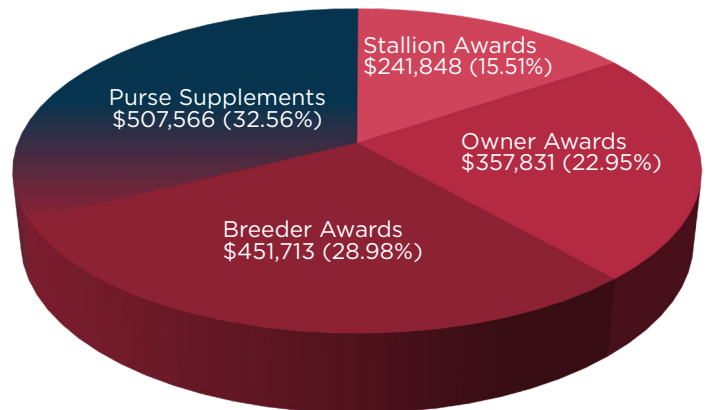
Standardbred

Total Distributed: \$14,710,610



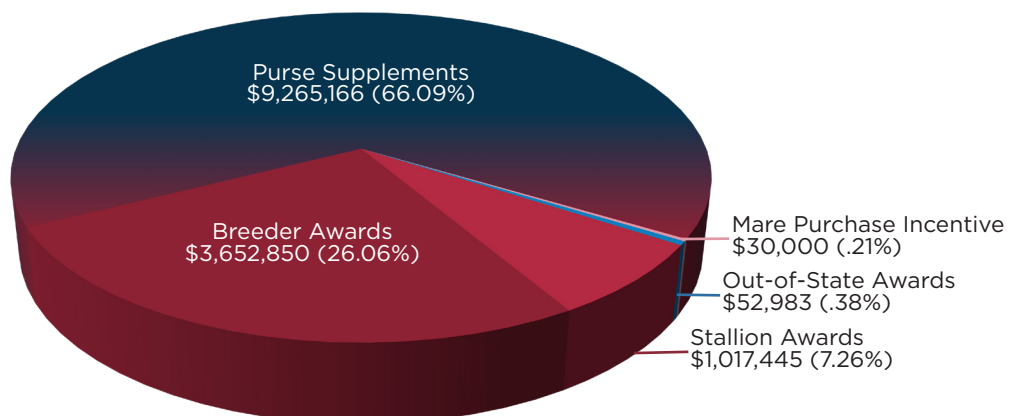
Quarter Horse

Marketing Initiatives

IC 4-35-8 charges the Commission with promotion of the Indiana horse racing industry. In 2025, the Indiana Horse Racing Commission (IHRC) introduced a new position to aid in this requirement. The Communications Coordinator position was created in an effort to grow the marketing and advertising efforts of the Commission's breed programs.

Approximately 2% of each breed development funds' budget is allocated each fiscal year to be utilized for these purposes. In 2025, a graphic designer was placed on contract to help create print advertisements and program materials.

In 2025, The Indiana Horse Racing Commission partnered with the Indiana Standardbred Association (ISA) in organizing an online contest for a VIP Prize Pack to the Indiana Governor's Cup Harness Racing Championship in August. The contest was advertised on 1075 The Fan's website and B105.7's website. The winner received state fair admission for 6 people, VIP seating, food vouchers, a private racing barn tour, and the privilege to present the Governor's Cup trophy in the fairgrounds winner circle. Assistant Executive Director, Jessica Barnes appeared on the podcast The Ride with JMV to discuss horse racing in Indiana and the State Fair Governor's Cup Championship.

The IHRC transitioned from utilizing GovDelivery to Marketing Cloud to send mass emails to its constituents and keeping them informed on upcoming deadlines and changes to the program. Informational fliers and checklists were also distributed at booths hosted by the Indiana Thoroughbred Owner's & Breeder's Association (ITO-BA) and the Quarter Horse Racing Association of Indiana (QHRAI).

In an effort to foster friendly competition and highlight Indiana winners, a leaderboard was introduced to IHRC's website and was updated bi-weekly along with the payment status for breeder awards. Facebook pages for the Breed Development programs were updated regularly to share news and congratulatory posts celebrating stakes winners. The IHRC partnered with Horsemen's Associations (ITO-BA, QHRAI, & ISA) to recognize the most accomplished horsemen of the year at the yearly awards ceremonies. The IHRC presented stakes winners and accomplished horsemen with crystal awards, totaling more than 100 trophies, across all three breeds.

Racino Slot Revenue

The 2007 Indiana Legislature approved slot machine wagering at the state's two pari-mutuel racetracks in accordance with 71 IAC 4-35-7-12. Racino slot revenue began replacing riverboat revenue in June 2008. These funds are distributed to various segments of the racing industry in accordance with Commission rule IC 4-35-7-12.
