

ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 3 - Inquiry posted on unofficial No. 4 DON'T TELL UR MOM (Joey Putnam) for possible pylon violation in the stretch. After reviewing video the judges determined that Mr. Putnam's wheel was inside one pylon, however this did not give the horse an unfair advantage. No reason for disqualification and the horse was placed as finished.

Race 7 - Inquiry posted on unofficial fourth place finisher No. 9 ODDS ON LIL ROCKER (Pete Wrenn) for possible interference to unofficial fifth place finisher No. 8 SPECIAL PETE (Brandon Bates) in the stretch. After reviewing video the judges determined that there was not conclusive evidence that interference occurred. Horses placed as originally finished.
