

### ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 1 - 35 minute delay before the first race due to thunderstorms in the area.

Race 2 - Due to a printing error, the claiming prices on No. 4 GO VIRAL, 5 GULLFAXI, and 8 CARANA were incorrectly printed in the program. Corrected prices scrolled on TV and announcements made by track announcer. Inquiry posted on unofficial third place finisher No. 6 CROWN HANOVER (Brandon Bates) for possible interference to unofficial seventh place finisher No. 5 GULLFAXI (Kyle Wilfong). After reviewing video and speaking with the drivers the judges determined that interference did occur. For interference No. 6 CROWN HANOVER finished third placed seventh. Driver Bates fined \$200.00 for interference causing a placing.
