


ADMINISTRATIVE ACTIONS, NOTES, COMMENTS


Race 6 – Kiwon Waldron, driver of No. 4 HAWT YOGA, fined \$100.00 for failure to set and maintain a proper pace during the second quarter.

Race 12 – Inquiry posted on unofficial fourth place finisher No. 1 GOLDEN NOTES (Marcus Miller) for possible violation of the breaking rule after the start. After reviewing video the judges determined that Mr. Miller complied with the breaking rule. However, the judges determined that the horse did make an extended break which per IHRC rules is any break that last for 25 strides or more. For violation of the breaking rule (extended break) No. 1 GOLDEN NOTES finished fourth placed seventh.

Race 13 – No. 10 HERWISH (Doug Rideout) originally finished sixth placed seventh for interference to No. 1 WHIP IT (Joey Putnam) in the stretch. No. 10 HERWISH drifted into the path of No. 1 WHIP IT causing that horse to make a break. Driver Doug Rideout fined \$200.00 for interference causing a placing.
