


### ADMINISTRATIVE ACTIONS, NOTES, COMMENTS


**Race 4** - No. 4 TELL'S SUPER STAR (Kyle Husted) originally finished eighth placed tenth for interference to trailing horses while on a break in the stretch. No. 5 GAROPPOLO charted with an interference break as a result of the actions of the No. 4 and therefore will not have to qualify for making repeated breaks.

**Race 9** - Separate inquires posted concerning the fair start pole and possible breaking rule violation. First inquiry involved No. 4 WEST STOKES (Trace Tetrick) and the fair start pole. Video confirmed that the horse was inside of the fair start pole prior to the remainder of the field being released by the starter. No. 4 WEST STOKES declared a starter for wagering purposes. Second inquiry involved the unofficial second place finisher No. 1 LETHIMGOJOE (Brandon Bates) and potential violation of the breaking rule in the stretch. Video showed that No. 1 LETHIMGOJOE flipped from the trot (programmed gait) over to the pace and continued to pace the rest of the way through the finish. For violation of the breaking rule No. 1 LETHIMGOJOE finished second placed seventh.

**Race 10** - No. 6 BLUEBIRD FANCYSWAN (Kiwon Waldron) originally finished eighth placed ninth for violation of the breaking rule in the stretch (extended break).
