ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 4 - Inquiry involving the start of the race and whether No. 2 LADY HELP (Chad Clark) made the fair start pole. Video confirmed that the horse was well outside of the fair start pole when the rest of the field was released by the starter. No. 2 LADY HELP declared a non-starter for wagering purposes and refunds issued on all bets made on the horse.

Race 6 - Roy Wilson, driver of No. 1 JD'S KING JAMES, fined \$100.00 for failure to set and maintain a proper pace.

Race 14 - Inquiry posted on unofficial second place finisher No. 8 CRESCENTROLLER (Brandon Bates) for possible interference to unofficial fourth place finisher No. 4 APERTIF (Atlee Bender) exiting the far turn entering the stretch. After reviewing video and speaking to both drivers (each concurred that the interference did take place), the judges placed No. 8 CRESCENTROLLER from second to fourth. Driver Brandon Bates fined \$200.00 for causing interference.
