



ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 2 – Inquiry posted on unofficial second place finisher No. 4 GALLEYS IMAGE for possible violation of the breaking rule at the finish. Video confirmed that No. 4 GALLEYS IMAGE made a break nearing the finish (at about the lowercase “h” in the Harrah's Hoosier Park infield logo) and remained off stride through the finish. However, the judges determined that there was no reason to place the horse because of the short time that GALLEYS IMAGE was off stride and the distance between her and the third place horse.

Race 13 – Inquiry posted on unofficial fourth place finisher No. 7 LATIN AMBITION (John DeLong) for possible violation of the breaking rule after ¾. After reviewing video the judges determined that driver John DeLong complied with the breaking rule and there was no reason for placing. Anthony Miller, driver of no. 4 COOL KINDA LADY, fined \$200.00 whipping with more than minimal wrist and elbow action.
