ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 2 - Recall due to interference before the start between No. 3 COFFEE STUFFER and No. 4 DON'T MIKE Inquiry posted on unofficial second place finisher No. 2 CHROMYS ROCKET (LeWayne Miller) for possible interference unofficial seventh place finisher No. 8 TOUCH OF ABILITY (Jordan Ross). After reviewing video the judges determined that No. 2 CHROMYS ROCKET came out into the path of No. 8 TOUCH OF ABILITY striking that horse's front legs causing it to make a break. (This was also confirmed by Mr. Ross after speaking with him). For interference causing a break No. 2 CHROMYS ROCKET finished second placed seventh. Driver LeWayne Miller fined \$200.00 for interference.


Race 3 - Claim on No. 2 TRUFFLE DOG voided as the horse was a late vet scratch due to lameness. Per IHRC rules a clam does not become official until a horse is an official starter (hears the word "go".)

Race 8 – Marcus Miller, driver of No. 3 SEARCH THE SEA, warned about using more than minimal wrist and elbow action while whipping in the stretch.

Race 14 – No. 4 MYSTIC SWAN (Kevin Lambright) originally finished eighth placed tenth for an extended break in the stretch.
