ADMINISTRATIVE ACTIONS, NOTES, COMMENTS


Race 5 - Inquiry posted on unofficial fourth place finisher No. 3 HELPONEANOTHER (John DeLong) for possible pylon violation in the stretch. Video showed that the horse was inside only one pylon and the judges determined that this did not give the horse an unfair advantage. No reason for disqualification and the horse was placed as finished.

Race 7 - No. 9 FOX VALLEY TRYEL placed on the steward's list for poor performance prior to making a break.

Race 9 - Purse correction to \$10,000 due to the fact that the race was no an SBDF race consisting of all Indiana-sired horses. No. 4 PILOT'S LUCKY DAY originally finished seventh placed eighth for violation of the breaking rule (extended break).
