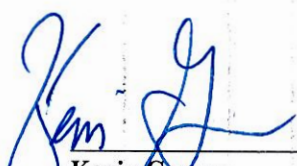

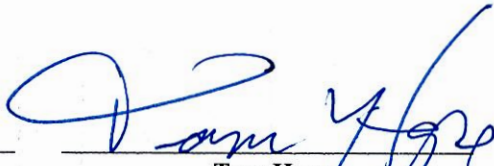
Race 4 - Late driver change on No. 6 NAKED ON A HILL from Atlee Bender to Jordan Ross. Mr. Bender fined \$200.00 for failure to drive when programmed.

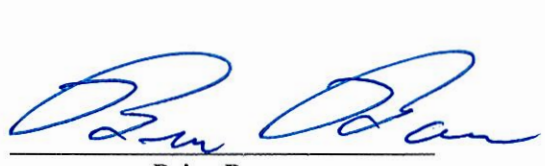
Race 9 - Inquiry posted on unofficial third place finisher No. 3 LAKE SIDE TAMMY (Marcus Miller) for possible violation of the breaking rule in the stretch. After reviewing video, the judges determined that driver Miller complied with all aspects of the breaking rule and the horse was placed as different.

No. 4 GREEN RIVER (Trace Tetrack) charted with an equipment break after the start (hobble) and did not finish due to the broken equipment.

Race 11- The scratch of No. 2 WATCH MISS TUCKY reduced the field to four betting interests. Per IHRC rules, trifecta and superfecta wagering on the race was cancelled. The track opted to cancel place and show wagering on the race.
