ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

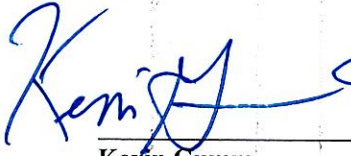
Race 2 - Inquiry posted on unofficial fourth place finisher No. 4 MISSKELLYSBABY (Brandon Bates) for possible violation of the breaking rule in the stretch. After reviewing video the judges determined that No. 4 MISSKELLYSBABY made an extended break. While reviewing video the judges also determined that No. 5 ISCREAMONTHEWAY (Kevin Lambright) DID NOT make an extended break and that driver Lambright complied with the breaking rule. No. 4 MISSKELLYSBABY finished fourth placed tenth for violation of the breaking rule. NO. 5 ISCREAMONTHEWAY was moved up to fifth via this DQ (No. 4 placed tenth), which the judges allowed to stand as explained in the previous sentence.

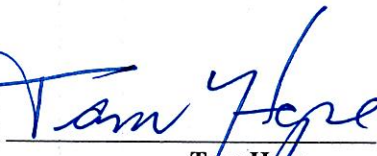
Race 9 - No. 4 LISTENTOME NELSON (Brandon Bates) originally finished seventh placed eighth for a lapped on break.

Race 10- General inquiry concerning an incident that occurred entering the far turn before 3/4. No. 2 FACT CHECK (Kyle Wilfong) and No. 6 ONE LUCKY DUDE (Anthony Miller) hooked wheels at that point. After reviewing video the judges determined that neither driver was at fault as Mr. Miller's horse was drifting out at the point that Mr. Wilfong's horse was drifting in. Both drivers attempted to take corrective action but still got hooked. Every horse in the race, with the exception of No. 7 KNIGHTS TEMPLAR A, given an "I" for interference or "im" for impeded. No placing or penalties issued to Mr. Wilfong or Mr. Miller.
