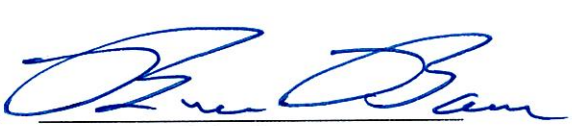
Race 1 - Atlee Bender, driver of No. 1 CAPTAIN SLEAZE fined \$100.00 for failure to drive when programmed.

Race 8 – Inquiry posted on unofficial race winner No. 7 TELL'S PURE POWER (Trace Tetrick) for possible violation of the breaking rule after the start. After reviewing video the judges determined that Mr. Tetrick complied with all aspects of the breaking rule. Horse placed as finished. Furthermore, although the horse was technically a break off qualifier, per IHRC rules, the horse will not have to requalify by nature of winning the race.

Race 13 – No. 5 GUITARS CADILLAC (Stephen White) originally finished fifth placed sixth for violation of the breaking rule (extended break) after the start continuing before the quarter.
