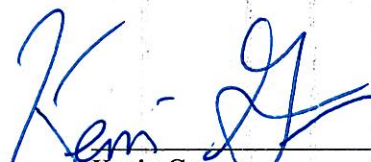

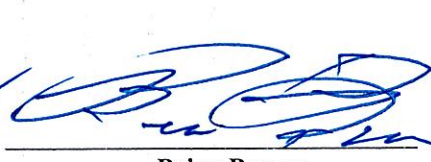

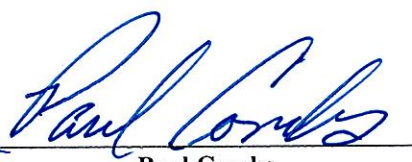

Race 2- Inquiry posted on unofficial race winner No. 1 LLOYD WRIGHT (John DeLong) for possible violation of the breaking rule after the quarter. After reviewing video the judges determined that No. 1 LLOYD WRIGHT jumped a pylon that had fallen on the track and No. 3 SWANKY YANKEE steered to the inside of the pylons to avoid the pylon on the track. The judges determined that with the break being caused by a fallen object to chart the No. 1 with an interference break and leave the horses placed as finished.
