ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 2 – Recall charged to No. 1 LITERALLY ROCKIN for interference to No. 10 GAGA while on a break before the start. Due to the lateness of the recall (one pylon before the start pylon) the windows were locked and remained locked for the reformation and subsequent restart. Director of Racing Gabe Prewitt was notified by the judges of this occurrence.

Race 10 – No. 2 SILVER CRUSADER (Daryl Bontrager) originally finished sixth placed tenth for a pylon violation in the stretch. After making a break and going to the inside for safety, Mr. Bontrager failed to reenter the track and passed horses while inside pylons in the stretch.

Race 11 - General inquiry looking at several incidents after 3/4 and in the stretch. The first incident was a possible pylon violation on unofficial fourth place finisher No. 4 SATIN SERENADE (John DeLong) nearing the finish. After reviewing video the judges determined that the horse was inside of two pylons, but did not gain an unfair advantage. Secondly, the horse was

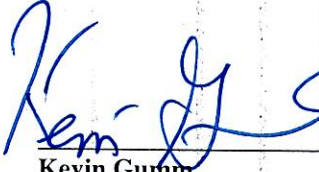
lapped on, however that horse No. 6 INTRICATE DANCER finished ahead of No. 4 SATIN SERENADE. No reason for placing.

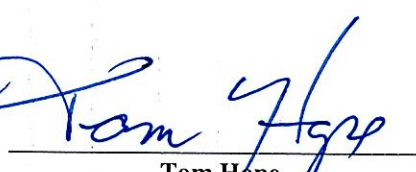
The second incident involved unofficial eighth place finisher No. 3 MEADOWBROOK SHELLY (Trace Tetrack) making a break after 3/4. The judges determined that the break caused interference to unofficial sixth place finisher No. 5

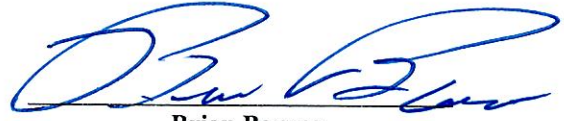
CANTHELPBELIEVIN (Austin Hanners). After reviewing video the judges determined that No. 3 MEADOWBROOK SHELLY did interfere with No. 5 CANTHELPBELIEVIN while on the break causing that horse to change course. However, the judges determined that No. 5 CANTHELPBELIEVIN made a break on her own at the top of the stretch, which turned into an extended break as she remained off stride through the finish.

No. 3 MEADOWBROOK SALLY finished eighth placed seventh placed eighth for interference to trailing horses while on a break.

No. 5 CANTHELPBELIEVIN finished sixth placed eighth for an extended break placed seventh for being interfered with before the break.
