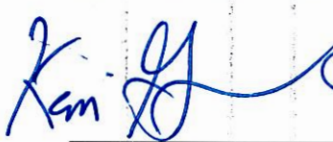

ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 2 - Recall due to broken equipment on No. 6 MAKE IT SPICY.

Race 12 - Inquiry posted on unofficial third place finisher No. 5 ALWAYS AT HARRY'S (Jared Finn) for possible violation of the breaking rule in the first turn heading to the quarter. After reviewing video the judges determined that driver Finn complied with all aspects of the breaking rule and that the horse did not make an extended break.

General inquiry posted looking at breaking horses at the top of the stretch. After reviewing video the judge's determined that both horses that made breaks broke on their own and neither was due to interference. Results made official.
