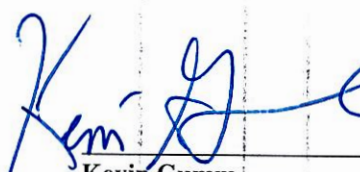
ADMINISTRATIVE ACTIONS, NOTES, COMMENTS

Race 1 – Inquiry posted on unofficial fourth place finisher No. 4 BRYSON SWAN (Mike Peterson) for possible violation of the breaking rule entering the turn in before the first quarter. After reviewing video the judges determined that the horse was on a break for at least 27 strides, which per IHRC rules, is an extended break (anything greater 25 strides or more constitutes an extended break). The judges also determined that Mr. Peterson failed to continuously lose ground while on the break. For violation of the breaking rule No. 4 BRYSON SWAN finished fourth placed sixth. Mr. Peterson called after the race asking for an explanation and was given the same answer.

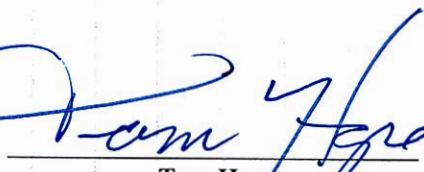
Race 7 – Inquiry posted on unofficial fourth place finisher No. 1 BROOKLETS GIRL (Cordarius Stewart) for possible interference to unofficial eighth place finisher No. 3 MIDNIGHT ATTIRE (Travis Seekman) in the stretch. After reviewing video and speaking with driver Seekman the judges determined there was not enough to warrant a placing. All horses placed as originally finished.

Race 8 – With the scratches of No. 1 KOUNTRY DION and No. 2 FIRE BALL HALL the field was reduced to five betting interests. Per IHRC wagering rules superfecta wagering on the race was cancelled.

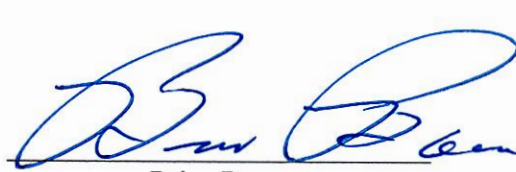
Race 10 – Driver change on No. 4 DIAL NINE ONE ONE from Anthony Miller to Marcus Miller (program error).
