Dear Standardbred Owner:

In this book, you will find information, conditions, schedules, registration forms, and nomination forms for the 2026 Indiana Standardbred racing program. Below you will find a few things I would like to highlight for the 2026 program, they are:

#### Indiana Sire Stakes Program:

- Improvements have been made to the Aged Sires Stakes program. Aged horses will now have an opportunity to compete in two legs to earn their way into the \$75,000 final.
- In order to be eligible for the final or consolation, horses must be credited with at least one (1) start in an Indiana Sire Stakes leg.
- All consolations and finals will be subject to detention.
- Legs with purses of \$75,000 or more will be subject to detention.

#### Indiana Sired Fair Circuit Program:

- In order to be eligible for the Governor's Cup Consolation or Championship race, horses must have participated in or be credited with at least seven (7) Indiana Sired Fair Circuit races.

You will find detailed information regarding race conditions, nomination deadlines and payment addresses for various races. Please pay close attention to all those items when nominating your horses. I would also like to remind you that nominations must be postmarked by the required deadline or they will not be accepted. Please be aware of this when dropping your payment into a mailbox on the day of the deadline. We encourage nominees to send payments via certified mail with a return receipt.

## *Mini-Series Rules*

**Harrah's Hoosier Park will have a variety of Mini-Series during the 2026 race meet for Indiana Sired horses. These series will appear on the overnight sheet and do not require a nomination or starting fee. For more information, please contact Jennifer Tuttle at (317) 233-3119 or the Race Secretary at Harrah's Hoosier Park.**

- 1. Nominations:** There are no nomination or starting fees required.
- 2. Race Conditions:**
  1. All horses must meet host track qualifying standards in order to be eligible to compete in Mini-Series.
  2. To be raced as an elimination(s) and a final.
  3. No trainer or owner may race more than two (2) horses per division in a Mini-Series, elimination or final.
  4. If there are thirteen (13) or fewer entries, twelve (12) starters will be determined by preference date, and also eligibles will be drawn. If there are fourteen (14) or more eligible entries the race will be split into divisions.
  5. Eliminations or finals will only take place if there are eight (8) or more betting interests, and may take place with seven (7) at the track's discretion.
  6. Horses with the highest point earnings from the elimination(s) who declare into the box will compete in the final. To be eligible for the final, a horse must have started in an elimination. The final will be limited to ten (10) horses. If there is a tie for tenth (10<sup>th</sup>) place, entry will be drawn by lot. Two (2) also eligibles for the final may be selected from the next two (2) highest point earners. If there are eight (8) or more additional eligible entries, a consolation for the next group of top point earners may be held at the discretion of the race secretary at elimination purse levels.
  7. No owner and/or trainer will be permitted to race two (2) horses in a Mini-Series to the exclusion of a single entry.
- 3. Claiming Mini-Series:**
  1. Horses may be claimed out of the elimination races or the final of these series.
  2. Claiming Allowances: 2 yr olds – 100%, 3 yr olds – 50%, 4 yr olds – 25%, Mares – 20%
- 4. Conditioned Mini-Series:** Horses which are eligible prior to the elimination of a series will remain eligible for final, regardless of their winnings after the elimination race.

# 2026 Standardbred Breed Development Policy on Breeder's Award Payments

## Indiana Sired & Bred Breeder Awards

### Indiana Sired & Bred (ISB):

\*For Foals of 2011 & beyond: A foal sired by a registered Indiana Stallion and from a mare which was registered & resided in the State of Indiana continuously from August 1st for foals of 2012 and beyond of the breeding year through the time of foaling and (30) thirty days after and is properly registered with the IHRC.

Breeder Award: An award paid to the registered breeder of an eligible horse (as defined below) using the following formula:

$$\text{Breeder's Awd Amt} = \% \text{ of win earnings in eligible races} * \text{Amt available } (\$1,000,000)$$

Breeder Defined: The breeder is the individual listed on the horse's registration papers as the breeder by the USTA. If the award is to be paid to a stable name/business then the registered owner must be listed as that stable name/business. If there are multiple breeders listed, the award will be paid to the individual listed first. It is the individual who receives the awards responsibility to distribute the award to the remaining listed breeders.

Who is Eligible for a Breeder's Award?: The horse must win an eligible race to be eligible to the Breeder's Award Pool. The criteria is as follows:

- Two Year Olds & Three Year Olds - Indiana Sired & Bred (ISB) Horses only that win any race at the Pari-Mutual Tracks in Indiana or ISFC Championship Races.
- Aged Horses - Four through Thirteen Year Old Indiana Sired & Bred (ISB) and Fourteen Year Old Indiana Sired (IS) that win:

\*Final of any Breed Development Indiana Sired Late Closer Event

\*Leg or Final of the Indiana Sire Stakes

\*Open or Invitational Race held at Harrah's Hoosier Park

Please Note: Breeder's Awards will be paid on an annual basis, at the completion of the race meet in Indiana. Breeder's Awards are paid by the Standardbred Breed Development Program, not the racetrack, and the award is not added to the horse's earnings. In order to receive an award, you must have a completed W-9 & Direct Deposit Form on file with the State of Indiana.

**To be Raced At:** Harrah's Hoosier Park in legs and Super Final as scheduled.

**Payments: (U.S. Funds)** One (1) nomination payment will allow a horse to be eligible excluding the Aged divisions.

Once a horse is drawn into the leg the entry fee is due, even if the horse is scratched prior to the race. *Please Note: There will not be an entry fee required for the super final.*

**Declaration:** Starters are to declare in at the regular time practiced at Harrah's Hoosier Park. All declarations are subject to Indiana Horse Racing Commission Rules.

An allowance of two (2) seconds will be allowed for pari-mutuel tracks that are less than 7/8<sup>th</sup> of a mile. An allowance of three (3) seconds will be allowed for any fair half-mile track. Additionally, any fair track rated sloppy will receive two (2) second allowance. Any Pari-mutuel track rated less than fast will receive one (1) second for good and two (2) for sloppy unless otherwise notated. All horses must have a good, charted line in qualifying time, without a break, within the last forty-five (45) days from race date.- Any horse eligible to the Super Final must have a good, charted line in qualifying time, without a break within the last forty-five (45) days from race date to race date.

**Entry Fee:** To be paid at the Office of the Director of Racing at the host track at least one (1) hour prior to post time.

**Money Division:** Purses for races will be divided 50-25-12-8-5 percent.

**Race Conditions:** Each event is to be raced one (1) heat at one (1) mile each. If eleven (11) or more horses declare to start, the leg will be split into divisions according to the attached chart on page #4. All finals will be raced. All legs will be contested, regardless of the number of entries. All drug testing samples, taken from horses competing in the Indiana Sires Stakes, may be frozen for future testing.

Legs whose divisions have purses of \$75,000 or more will be subject to detention. All finals and consolations will be subject to detention. The top ten (10) horses from the legs who declare into the box will compete in that super final. If two or more horses are tied, entry will be drawn by lot. A horse must have started in at least one (1) leg in order to be eligible for the super final or consolation. After the super final is determined, the next ten horses from the legs who declare into the box will compete in the consolation. If there is a tie for 10th place, entry will be drawn by lot. All post positions will be drawn. Consolations must have a minimum of five (5) entries to take place. Points will be awarded in each leg final as follows: 1st 50 points; 2nd- 25 points; 3rd-12 points; 4th-8 points; 5th-5 points. All starters will receive one (1) point for each leg raced.

**Purses:** Legs with eight (8) betting interests, the race may be raced as non-pari-mutuel event at the discretion of the race secretary. If there are fewer than eight (8) betting interests, the race may be raced as a pari-mutuel race for the full advertised purse at the discretion of the race secretary.

Each 6<sup>th</sup> – 10<sup>th</sup> place finisher in the Super Final shall receive \$4,000.

Legs with eleven (11) starters, an additional 6% of the total purse will be paid; 3% will be paid to the 6<sup>th</sup> place finisher, 2% will be paid to the 7<sup>th</sup> place finisher, and 1% to the 8<sup>th</sup> place finisher.

All entrants must abide by this change or forfeit their right to participate in these races or race for any part of the purse. In all circumstances, the Board will make the final decision.
- Gait:** Horses changing gait may be transferred to their adopted gait, but payments made prior to that time will not be transferred.
- Rules:** Rules of the Indiana Horse Racing Commission shall govern unless otherwise specified in these conditions. Any issue not covered by these conditions or Indiana Horse Racing Commission Rules will be subject to interpretation at the discretion of the host track.

## 2026 General Conditions for Events to be raced at Harrah's Hoosier Park

1. These events will be conducted under the rules and regulations of the Indiana Horse Racing Commission, Indiana Standardbred Breed Development, Harrah's Hoosier Park, and the United States Trotting Association.
2. All of these events are to be raced as a late closer, contested at Harrah's Hoosier Park, Anderson, IN.
3. Purses for all races will be divided 50-25-12-8-5%.
4. Nominations close on the dates posted in the nomination book and must be postmarked on the dates posted on the condition book. Payment for nomination fees must be in U.S. Funds and made payable to Indiana Horse Racing Commission.
5. Declarations close at the time and date posted on the condition sheet.
6. Horses must have raced in one leg in order to qualify for the final.
7. Ten (10) horses with the highest money earnings in the series will compete in the finals. If horses from the top ten fail to declare in the finals, the next highest money earners who declare in will be eligible. All ties will be drawn by lot. Two (2) also eligibles for the finals may be selected from the next two (2) highest money earners.
8. Divisions will be split according to the Sires Stakes guidelines. Per Indiana Horse Racing Commission Rules – The 45 day rule is in effect (race date to race date) in accordance with the rules and regulations of the Indiana Horse Racing Commission.
9. All events will be contested at one mile. Horses must meet qualifying standards at Harrah's Hoosier Park.
10. Post positions for preliminary legs for all events to be drawn by lot. The horse with the highest earnings in each respective series shall pick their post position for the final. In the event of a tie, the order in which horses pick their post will be determined by lot, between those horses involved in the tie.
11. The winner of the Cardinal final shall receive an automatic nomination to the Expresson with no obligation to pay the nomination fee. If the horse already nominated to the Expresson, then a refund shall be given.
12. The winner of the Mya Tri final shall receive an automatic nomination to the Msnaughtbynature with no obligation to pay the nomination fee. If the horse already nominated to the Msnaughtbynature, then a refund shall be given.
13. The winner of the Jerry Landess final shall receive an automatic nomination to the Hal Dale with no obligation to pay the nomination fee. If the horse already nominated to the Hal Dale, then a refund shall be given.
14. The winner of the Miss Windfall final shall receive an automatic nomination to the Go On BB with no obligation to pay the nomination fee. If the horse already nominated to the Go On BB, then a refund shall be given.

- For:** Fair races for Indiana Sired and Bred (ISB) foals of 2023 and 2024, as defined by 71 IAC 14-1-3. Championship races at the Indiana State Fair to be held for ISB foals of 2023 and foals of 2024.
- To Be Raced As:** One level for 2- and 3-Year-Old Trotters and Pacers in 2026. Also to be raced as a Championship and Consolation race at the Indiana State Fair for 2- and 3-year-old Trotters and Pacers in 2026 based on points earned in the Fair Circuit.
- Two Year Olds – NW \$7,000 in 2026 up to and including 9/01/2026
- Three Year Olds – NW \$7,000 in 2026 up to and including 9/01/2026
- Locations to be designated annually by the Sponsor.
- To Be Raced At:** **Two Year Olds**  
April 15, 2026 - \$300
- Nominations:** **Three Year Olds**  
March 15, 2026 - \$300
- No sustaining fees are due.  
(Payable to Host Track)
- Future Payments:** *Once a horse is drawn into an ISFC event, the entry fee is due, even if the horse is scratched. If entry fee is not paid, the horse will be ineligible to start in all subsequent fairs.*
- Entry Fees:** Entry Fee ..... \$50.00  
*Please Note: There will be no entry fee required for the Championship or Consolation race, but horses must check in at the race office at least ninety minutes prior to the post time.*
- Future Eligibility:** If the two-year-old nominating payment is not made, an eligible foal may be nominated as a three year old.
- Entry Fee:** To be paid at the office of the director of racing at each host track prior to the start of the races.
- Money Division:** Purses will be paid 50-25-12-8-5 percent. In the event of a field of less than five in the Consolation, all retained monies will be returned to the Indiana Standardbred Breed Development Fund.
- Race Conditions:** Each event is to be raced one heat at one mile each. There are no eliminations. The event may be raced in divisions, according to USTA rules with the following exceptions:
- For horses competing in the ISFC races held at Hoosier Park, qualifying standards will not be required. However, all horses must have at least one charted line in the ISFC program during 2026 in order to compete in ISFC races hosted at Hoosier Park. Additionally, all participants must meet IHRC licensing requirements for the ISFC events held at Hoosier Park.
  - If there are a minimum of five fillies and five colts in the specified level, the race will be split into divisions based on sex. If the minimum of five (5) entries is not met, the race will not be contested.
  - If the minimum of five fillies and/or five colts is not met, all entries for that level will be in division(s) to be drawn at lot, with fillies drawing the inside post positions.
  - No horse may compete in any ISFC event who has raced in any other race on the day of, or on any two (2) days prior to the event (qualifiers and rained-out ISFC events excluded).
  - No horse may compete in an ISFC event who has raced in a Pari-mutuel event (ISFC event held at Hoosier Park excluded) on the day of or five (5) days prior to the event. *For example:*

## *Explanation of Fees*

**REGISTRATION FEE:** Registration fee of \$150 required for stallions to register for the 2027 breeding season (February 15—July 15). **Registration deadline is October 1, 2026.**

**LATE REGISTRATION FEE:** Stallions who have been previously registered in Indiana and fail to meet the October 1 deadline will be charged a late fee of \$250 in addition to the \$150 registration fee, for a total of \$400. **The late fee is waived for a new stallion which has never been previously registered in Indiana registering after the deadline. However, new stallions must pay the \$150 registration fee.**

## *Guidelines for Registration*

### **71 IAC 14-2-1 Stallion registration**

Authority: IC 4-31-3-9

Affected: IC 4-31

Sec. 1. (a) In order to register a stallion with the commission, a completed application must be:

(1) filed with the commission on or before October 1 of each year; and

(2) submit annual registration fee of one hundred fifty dollars (\$150) with registration.

(b) Each registered stallion must remain in Indiana the entire breeding season (February 15 through July 15) unless the approval to leave the state is requested and granted. The request must be made in writing and may be submitted via e-mail, fax, or mail.

(c) Stallions not registered by the October 1 deadline may be registered with an additional two hundred fifty dollar (\$250) late fee; however, this late fee will be waived for a stallion standing its first season in Indiana. Stallions must be registered for the current breeding season prior to covering any mares in Indiana.

(d) A registered stallion may leave the state for racing purposes; however, the commission must be notified in writing by email, fax, or mail seventy-two (72) hours prior to that stallion leaving the state to race.

(e) The commission must be notified in writing by e-mail, fax, or mail and provide proper documentation for any registered stallion leaving the state for medical treatment. Notification must be made within seventy-two (72) hours of date which the stallion left the state.
