



Registration Checklist

Welcome to the Indiana Thoroughbred Breed Development Program! You are about to be a part of one of the most lucrative regional breeding programs in the nation.

To help make the registration of your Indiana-bred easier, follow this checklist to ensure that you've followed through with all the requirements in order to race for our Breed Development Program Incentives.

MARES

November 1 - Mare must enter Indiana & be registered with the Indiana Horse Racing Commission by *November 1st* of the year prior to foaling and remain in Indiana continuously until foaling.

You can register [online](#) or print the [Mare Registration](#) and mail it in

Mare applications must be completed annually.

If your mare enters Indiana after November 1st of the year prior to foaling or Mare Registration is not completed by the deadline:

- Mare must reside in Indiana at time of foaling.
- Mare must be registered with the IHRC no later than 10 days of foaling.
- Mare and foal must remain in Indiana for 30 days after foaling.
- Mare must be bred back to a registered Indiana stallion after foaling.

* If you move your mare during the required residency timeframe, you must notify the IHRC by submitting a [Change of Residency](#) form either [online](#) or by printing the form and mailing it in.

FOALS

Foals must be registered within the **first year** of the foaling date to avoid late fees

You can register [online](#) or print the [Foal Registration](#) and mail it in

Late fee schedule is as follows:

12 months + 1 day to December 31st of yearling year: \$200

2 years old: \$400

3 years old & older: \$1,000



- October 15** – Stallion must be registered by *October 15th* of the year prior to breeding season. Stallions must remain in Indiana for the entire breeding season (*February 1 through July 1*).
- Stallion must be registered before covering any mares.
- You can register [online](#) or print the [Stallion Registration](#) and mail it in:
- An application must be filed every year the stallion breeds in the state of Indiana.

A late fee of \$250 will be assessed for late registration of any returning stallion.

The late fee (\$250) is waived for new stallions standing their first season in Indiana. New stallions arriving late cannot have covered any mares in another state during the same year.

* If you move your stallion during the required residency timeframe, you must notify the IHRC by submitting a [Change of Residency](#) form either [online](#) or by printing the form and mailing it in *

*You can check with the IHRC to ensure that your horse (mare, foal or stallion) is registered.
