### **Historical Note:**

The Indiana Department of Conservation was established in 1919 under Governor James P. Goodrich. A precursor to the Department of Natural Resources, it consisted of five divisions: Geology, Entomology, Forestry, Lands and Water, and Fish and Game. Its creation followed the establishment of Indiana's first two state parks, McCormick's Creek and Turkey Run, to celebrate the state centennial in 1916.

From 1919-1933, there was a four-member Conservation Commission appointed by the Governor to help run the department. After it was disbanded, a State Conservation Advisory Committee (1933-1941) was established. The committee consisted of delegates from thirteen state districts who came together quarterly to discuss legislation and general conservation issues. The Conservation Commission was reestablished by the Acts of 1939.

Integral to the department's founding was German-born Richard Lieber, who would become its first Director. Lieber oversaw the creation of McCormick's Creek and Turkey Run State Parks in 1916 as the Chairman of the State Parks Committee. He would go on to oversee the establishment of eight more State Parks during his tenure as Director (1919-1933). Lieber resigned from the department in 1933 when newly elected Governor McNutt dissolved the Conservation Commission and stifled Lieber's role as director.

Born in 1869, Lieber moved to Indianapolis in 1891 to join two of his uncles. He became an ardent conservationist after visiting Yosemite, CA in 1900. He would even go on to serve as a delegate to a conference on conservation at Theodore Roosevelt's White House in 1908. After his first visit to Brown County in 1910, Lieber suggested to his wife that it should be bought by the state and made into a park, thus birthing the state park idea he would pursue for the rest of his life.

Lieber referred to creating the state parks as "his life's work" and called his fourteen years at the helm of the Department of Conservation the "happiest in his life". He passed away in 1944 at McCormick's Creek Canyon Inn and his ashes were buried at Turkey Run State Park. At the time of his passing, he was considered the foremost conservationist in America. He is known today as the father of Indiana State Parks.

### **Scope and Content Note:**

This collection includes correspondence, administrative files, financial records, speeches, legal opinions blueprints, maps, publicity, and publications related to the Indiana Department of Conservation and its first Director, Richard Lieber, from 1901-1944. The collection was pulled from a larger collection on the

Department of Conservation to suit the needs of a researcher writing a dissertation on Richard Lieber. The records were organized into named folders, seemingly in Lieber's time, thought it cannot be confirmed who organized and named them or when. Only part of the collection was processed. The original collection lacked arrangement, so a new series-level arrangement was created with the assistance of the folder names. The original folder names were kept, wherever possible, in the new arrangement.

The new arrangement is made up of seven series: Department of Conservation, State Parks, Conservation Commission, Legal Files, Indiana Governors, Speeches, and Publicity and Publications. Each series is arranged by subseries, and then chronologically. There is a folder-level inventory.

The Department of Conservation series includes Richard Lieber correspondence<sup>1</sup>, administrative files, memos, financial records, and files from department divisions such as Forestry, Lands and Water, and Fish and Game. The series spans four decades and provides insight into the creation of the department into its first two decades.

The State Parks series is the largest, and it includes general correspondence about the creation of a state park system in Indiana, as well as records pertaining to the creation and running of specific state parks. The major parks include Brown County State Park, Clifty Falls State Park, Indiana Dunes State Park, Pokagon State Park (previously Lake James State Park), McCormick's Creek State Park, Spring Mill State Park, and Turkey Run State Park. Most of these records are correspondence. Discussion of funding and land acquisition, planning, and logistics can be found in this correspondence. There are also records pertaining to various memorials around Indiana, including the Lanier Mansion, the George Rogers Clark Memorial, and the Lincoln Union Memorial.

The Conservation Commission series includes correspondence from commission members and minutes from the Conservation Committee (1933-1941). A notable Commission member is Dean Stanley Coulter of Purdue University.

The Legal series includes state legislature records and correspondence, state Attorney General opinions, Department regulations and resolutions, and files pertaining to legal considerations at specific locations.

The Governor series contains records from almost every governor during the collection's timespan. This includes Gov. Durbin, Gov. Hanly, Gov. Marshall, Gov. Ralston, Gov. Goodrich, Gov. McCray, Gov. Jackson, Gov. Leslie, Gov. McNutt, and Gov. Schricker. Most of this series is made up of correspondence, which includes discussion of appointing the first State Entomologist and pre-Department of Conservation Fish and Game issues. Another folder of note contains miscellaneous Gov. Goodrich correspondence about World War I, covering a wide span of issues from coal restrictions, the 2<sup>nd</sup> Indiana Field Artillery's role in the war, and National Guard discharge requests. There is an item level inventory for this folder.

The Speeches series contains transcriptions of conservation-related speeches given across Indiana by Richard Lieber.
