Biographical/Historical Note:

Governor Maurice Clifford Townsend (b. August 11, 1884 d. November 11, 1954) served as the 35th Governor of Indiana from 1937-1941. He was a member of the Democrat Party. Prior to his election as Governor, Townsend served as the 33rd Lt. Governor of Indiana under his predecessor Governor Paul V. McNutt. He was succeeded by his Lt. Governor Henry F. Schricker in 1941 as the 1851 Constitution prevented Governors from serving consecutive terms.

During his tenure as Governor, the United States was still recovering from the effects of the Great Depression. Unemployment remained elevated, many constituents were still seeking employment, and CCC and WPA projects were still playing a major role. Townsend faced several crises early in his tenure. The first was the Great Flood of 1937, which decimated the Ohio River Valley and caused cities and towns to evacuate. The floods left hundreds of thousands of residents homeless in Indiana alone. The second was the 1937 General Motors Labor strike, which led to Townsend ordering the National Guard to Anderson to quell violence and prompted the creation of the State Division of Labor to mediate labor disputes.

He was a firm supporter of President Franklin Roosevelt and New Deal policies. His firm support even led to a noteworthy dispute with state Democratic party chairman Frederick Van Nuys over Roosevelt's attempt to expand the Supreme Court, which Senator Van Nuys vehemently opposed. Some other notable legislative accomplishments include the driver's license examination, pensions for firefighters, free textbooks for public schools, and school buses being painted yellow. The latter, of course, led to other states following suit.

Scope and Content Note:

The collection covers 1933-1941 with the bulk of the records consisting of correspondence covering Townsend's tenure as Governor from 1937-1940. The general correspondence is between Governor Townsend, or his office, and constituents, state agencies, or organizations. Subjects vary greatly, but some common correspondence concerns employment and welfare assistance, policy and legislation, constituent concerns, civil rights, labor issues, civil engineering projects, and recommendations for vacant positions. Constituent concerns regarding employment and welfare dominate the correspondence covering Townsend's first two years but declined significantly in the succeeding years.

Also included in the collection are proclamations, pardons, extraditions, appointments, meeting minutes, court cases, commission reports, invitations, West Point recommendations, legislation, and speeches and addresses. Noteworthy correspondence includes the Anderson Labor Strike in 1937, which details the Governor's decision to call in the National Guard, mediation strategies, commendation letters, and the creation of the State Division of Labor. Another is the Great Flood of 1937, which covers the effects of the flood, flood response, activity logs, and relief assistance. Lastly, there is correspondence with constituents, especially the Jewish community, and the Federal Government regarding the rise of antisemitism in Europe and the escalation of World War II.

Arrangement:

The collection is divided by each year of Governor Townsend's tenure and predominantly arranged alphabetically by last name or name of agency, organization, or business. The bulk of the material is general correspondence; however, there are several sub-series. There are two boxes of 1939 correspondence regarding the General Assembly and Proposed Legislation arranged alphabetically by the legislative topic or subject. Two boxes of 1938-1939 subject correspondence, arranged in no particular order, concerning various subjects including proclamations. Two boxes of speeches and addresses are arranged chronologically. One box includes appointments from 1933-1941 arranged alphabetically by the last name of the appointee. Two small boxes of invitations declined and accepted from 1940 are arranged chronologically by month. Lastly, there are two boxes of miscellaneous subject correspondence covering 1936-1938. The miscellaneous correspondence includes several folders of correspondence with publishing companies concerning state adoption of textbooks arranged alphabetically by publisher name.
