Records in this collection pertain to all correspondence filed between Governor Branch, his secretaries, and various groups and individuals seeking to get in touch with the Governor. Branch served as the 31<sup>st</sup> Governor of Indiana, finishing the term of Warren T. McCray, who resigned on April 30, 1924, after being convicted of mail fraud. Key issues during Branch's term include improvements to Indiana's schools and highways, and public opposition to Defense Day/Mobilization Day in September 1924. He left office on January 12, 1925.

    - Clemency granted in 649 cases, 202 of which were made by Branch.
    - Listings include the prisoner’s name, date, institution, action taken, and individual making the recommendation of such action.
