Records in this part of the collection include all documents from the original collection that have not been filed under Petitions: Pardons, Paroles, and Remission of Fines; Recommendations, Appointments, and Applications; or Correspondence by Subject. Documents include invitations to events; opinions regarding Leslie and his staff; requests for Leslie's autograph; information, reports, and statistics on specific organizations and subjects (particularly Boxes 36-47), and other assorted correspondence.

General Notes on the Collection:

- Harry G. Leslie served as Governor of Indiana from January 14, 1929 January 9, 1933.
- Leslie appointed John J. Brown Secretary to the Governor in January 1929, but by April he no longer held the position. He later became Director of the Highway Commission.
- Lewis O. Chasey and Gaylord S. Morton both served as Secretary to the Governor and answered many of the letters Leslie received during his time in office. Leslie charged Morton with responding to petitions for parole or pardon.
- Rose Sapirie and Elsie Leo were secretaries in the office.
- Indiana hosted a Conference of Governors in French Lick, IN, 1931.
- Leslie presided over the dedication of flagstaff at Lincoln's Boyhood Home, June 12, 1931.
- Leslie's term coincided with the onset of the Great Depression and was plagued with drought, unemployment, and labor troubles.
 - Large portions of the collection pertain to people seeking relief and state aid to localities.
 - See L.O. Chasey's letter to Leslie, August 12, 1930 (Box 43, Folder 7, In Re: Taxation) for a good example.
 - Other noteworthy correspondence includes letters concerning the Lindbergh baby kidnapping, the Marion lynching, proposed legislation, and the \$1.50 tax.
 - The \$1.50 tax bill proposed a limited tax rate on property and many individuals wrote to Leslie strongly supporting or opposing it.
- In the collection, Leslie takes a neutral stance on questions regarding prohibition.

Records in this part of the collection include numerous petitions for parole or pardon and remission of fines during Gov. Leslie's term. All applications for clemency had to be made to the Governor. Leslie charged Secretary Gaylord Morton with handling the task and Morton made several trips to Michigan City to attend parole hearings. Morton is also the primary correspondent with individuals, sending petitions, inquiries, and other messages related to the status of inmates in Indiana. Individuals could earn parole when they filed a form, had served their minimum sentence, and could get the judge and prosecutor of their case to agree to it. Prisoners could be granted temporary parole in cases of death in the immediate family, but were denied if he/she was in poor standing with the prison or if the parole involved out-of-state travel. Many letters in the collection come from family members seeking parole for their loved ones in the midst of the Great Depression and drought years.
